NOTICES UNDER THE WASTE LANDS ORDINANCES.

[Notice under "The Waste Lands Ordinances, 1897, 1899, and 1900."]

TAKE notice, that unless within three months from the 26th day of July, 1900, the persons, if any, who claim any interest in the lands hereinafter mentioned or in any one or more of such lands, appear before the Assistant Government Agent of the Kegalla District at the Kegalla Kacheheri and make claim to the said lands or any of them or to some interest therein :

Such Assistant Government Agent, in pursuance of the powers in him vested by Ordinance No. 1 of 1897, shall declare by writing under his hand that the said lands or such of them, as to which no claim has been made, are the property of the Crown.

Description of Lands referred to.

The following lots, situated in the village Ginihappitiya in Tumpalata pattu of Paranakuru korale, in the Kegalla District, as described in the annexed plan :-

Rahamen Levvai, Hepaddayakumbura claimed by T. D. Kirimenika and others, Eddriyakotuwa claimed by U. L. H. Ahammado Levvai, Nagollewatta claimed by J. D. Dontiya and others ; on the east by a stream reservation, Nallukohukumbura claimed by Medagoda Durayalage Subaya and others ; on the south by Wakkadakumbura claimed by M. D. Subaya and others, Delpathdeniya claimed by Kiri Banda, Delpathdeniya claimed by T. Dingira, Delpathdeniya claimed by Kirimenika, Halhena claimed by V. Ukkuwa, Halhena claimed by Wappu Levvai, Halhenawatta claimed by B. Kiri Saduwa ; on the west by Walawattetennahena claimed by P. U. Puncha, Galmullehena claimed by V. Ukku.

II.

Lot 376 on preliminary plan 188 called Hinneambemukalana, in extent 3 acres 2 roods and 2 perches ; and bounded on the north by Wakkadakumbura claimed by M. D. Subaya and others, Nalukohukumbura claimed by Medagoda Durayalage Subaya and others ; on the east by a stream reservation ; on the south by Walaliyadda claimed by Sinna Pillai and Titabagalakumbura claimed by Ahammado Levvai and others ; on the west by Hinneambahena claimed by M. Dingira and others.

III.

Lot 5,429 on preliminary plan 8,100 called Ambaragodahena, in extent 2 acres 1 rood and 2 perches: and bounded on the north by Walaliyadda claimed by Pulli Levvai ; on the east by a stream reservation ; on the south by Deniyepallekumbura claimed by R. Naide ; on the west by Pansalwatta claimed by D. Unnanse, Ambaragodahena claimed by R. M. Kuda Etana.

IV.

Lot 5,430 on preliminary plan 8,100 called Kurukayehena, in extent 5 acres 2 roods and 14 perches ; and bounded on the north by Kurukayehena claimed by Kirihami and others, Kurukayehena claimed by Baladuraya and another, Deniyapallekumbura claimed by R. Naide ; on the east by a stream reservation ; on the south by Kurukayehena claimed by S. M. L. C. Levvai ; on the west by Kurukayedeniya claimed by Ana K. Marikar, Kurukayehena claimed by J. Naide and others.

N.B.—The land appearing on title plan 157,797 called Kamata (threshing floor, P. P. 188/426) included within the boundaries of lot 3,775 and I 26 on preliminary plan 188, is excluded from this notice.

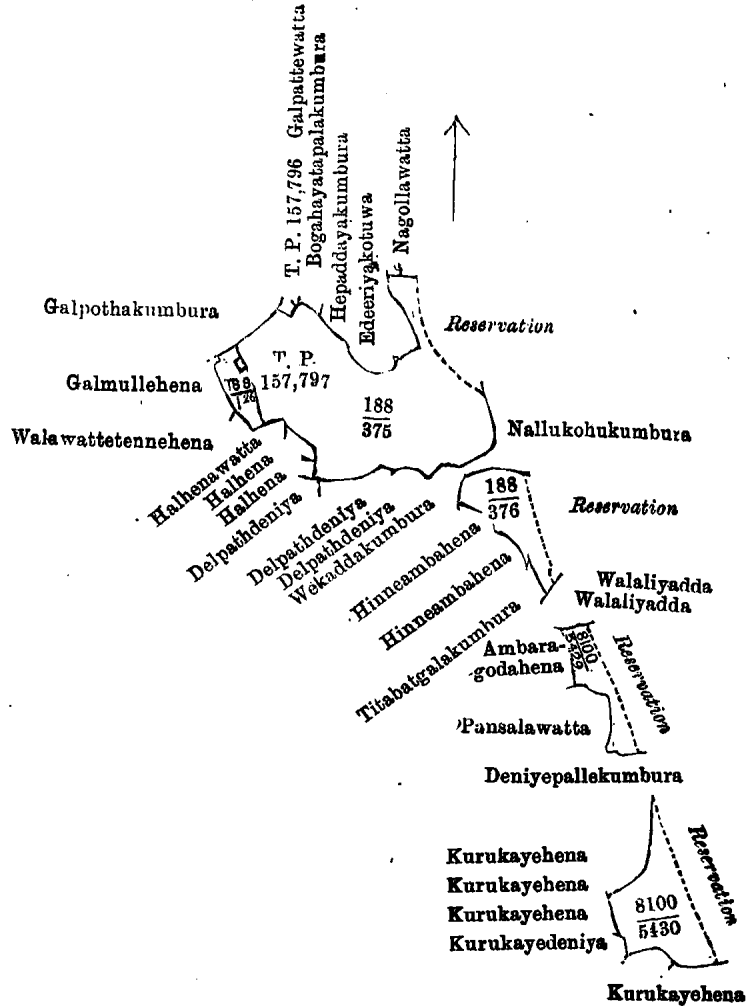
