NOTICES UNDER THE WASTE LANDS ORDINANCES.

[Notice under "The Waste Lands Ordinances, 1897, 1899, and 1900."]

TAKE notice, that unless within three months from the 10th day of August, 1900, the persons, if any, who claim any interest in the lands hereinafter mentioned or in any one or more of such lands, appear before the Special Officer appointed under section 28 of Ordinance No. 1 of 1897 at his office at Matara and make claim to the said lands or any of them or to some interest therein :

Such Special Officer, in pursuance of the powers vested in him by Ordinance No. 1 of 1897, will declare by writing under his hand that the said lands or such of them, as to which no claim has been made, are the property of the Crown.

Description of Lands referred to.

I.

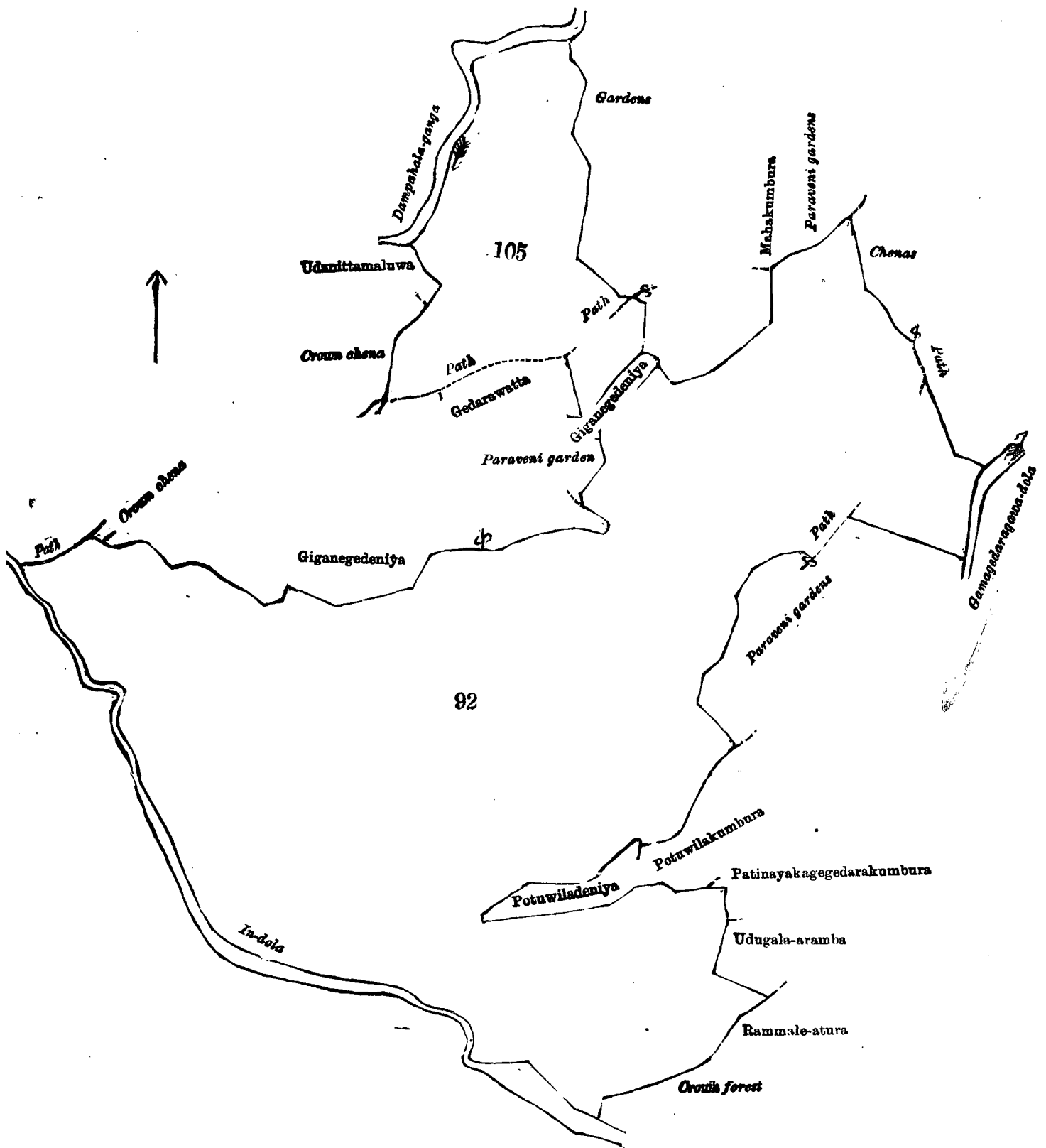
The land commonly called or known as Nittamaluwehena, situate in the village of Dampahala in the Morowak korale of the Matara District, in the Southern Province, containing in extent 17 acres 3 rood and 15 perches, shown as lot 105 in sheet O 15 21-29, as described in the annexed certified tracing therefrom, and bounded as follows : on the north by the Dampahala-ganga ; on the east by Munwattegepahalawatta claimed by Munwattege Baba and others, and Giganagedeniya belonging to G. W. Garuhamy and others ; on the south by Gedarawatta belonging to M. Babehamy and others and the footpath ; on the west by Boralukeyiyahena belonging to Crown, Udammattalawa belonging to W. Babehamy and others, and the Dampahala-ganga.

II.

The lands commonly called or known as Kapatenumekumbura, Muttettuwehena, &c., all lying adjacent to each other and forming one block, situate in the village of Dampahala in the Morowak korale of the Matara District, in the Southern Province, containing in extent 118 acres and 24 perches, shown as lot 92 in sheet O 15 22-29, as described in the annexed certified tracing therefrom, and bounded as follows : on the north by the footpath, Inelahena belonging to Crown, Giganagedeniya belonging to G. W. Garuhamy and others, Gedarawatta belonging to M. Babehamy and others, Giganagedeniya belonging to G. W. Garuhamy and others, Pahalawatta claimed by M. Babehamy and others, Mahakumbura belonging to M. Baba and others, Egodaawatta claimed by Yakgahawitige Dassan and others ; on the east by Batalawattehena claimed by Yaddehige Don Pediris and others, the Gamagedaragawadola, Udumullewatta claimed by Samarasinge Don Bastian and others, Potuwilakumbura belonging to P. Kottan and others, Potuwiladeniya claimed by P. Kottan and others, Patinayakagegedarakumbura belonging to P. Kottan and others, Udugala-aramba belonging to P. Kottan and others, and Rammaleatura Crown forest ; on the south and west by the Indola.
