## NOTICE UNDER ORDINANCE No. 1 OF 1897.

[An Ordinance relating to Claims to Forest, Chena, Waste, and Unoccupied Lands.]

### Order under Section 2 of Ordinance No. 1 of 1897, declaring Land to be Crown Property.

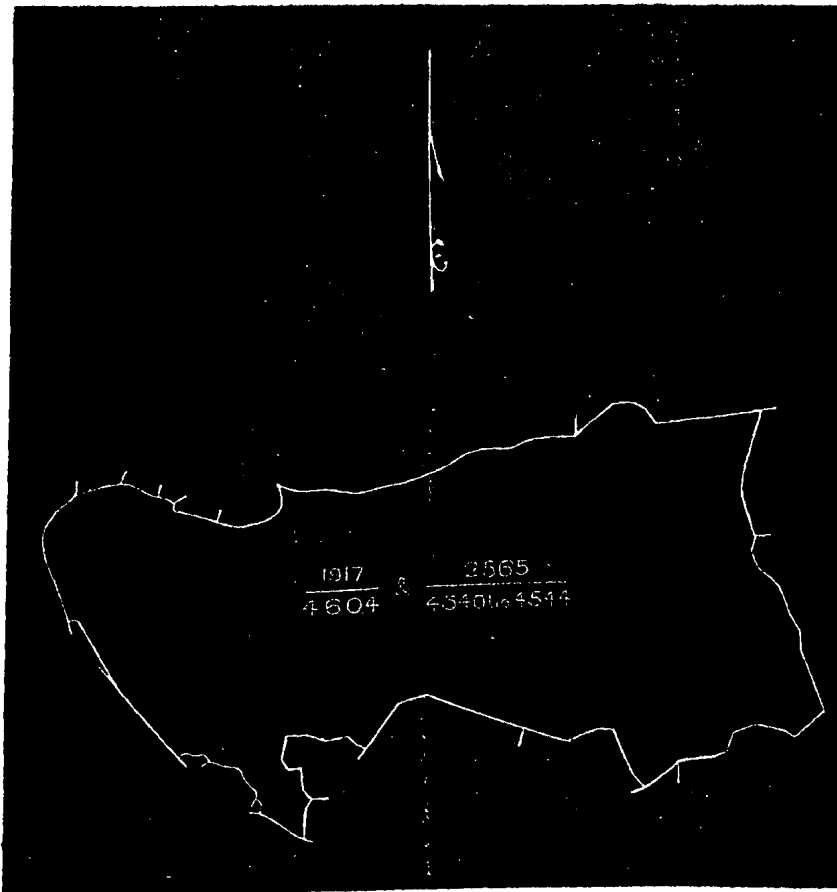
In the matter of the land commonly called and known as Kotigalahena and Kalugalkanda, situate in the village of Porambakananke, in the Matara-Weligam korale, in the Southern Province, and of the Ordinance No. 1 of 1897.

THE notice required by section 1 of the Ordinance No. 1 of 1897 having been published in the manner described by that section (*vide Government Gazette* of September 3, 1897) in respect of the above-named land, and no claim having been made to the said land or to any interest therein within the period of three months from the said date of the said notice :

I, John Penry Lewis, Special Officer under section 28 of the Ordinance No. 1 of 1897, under and by virtue of the powers vested in me in that behalf by section 2 of the said Ordinance, do hereby on this 18th day of January, 1898, order and declare that the said land commonly called or known as Kotigalahena and Kalugalkanda, situate in the village of Porambakananke, in the Matara-Weligam korale, in the Southern Province, and shown as lots 4,540, 4,541, 4,542, 4,543, and 4,544 in preliminary plan 2,565 and lot 4,604 in preliminary plan 1,917 of lands situated in the said village, a certified copy whereof is hereunto annexed, and containing in extent about 130 acres, and bounded as follows: north by land appearing in title plan 97,978, Vitanagedepola belonging to C. D. Dimmis Appahami, Gedarakumbura belonging to Don Dias, Egodawatta belonging to G. Menchihami, Egodawatta belonging to Simon Dias, Kandewattadola Pahaladeniyakumbura belonging to N. Punchi Baba, and Heenasakumbura belonging to R. H. Jura and others; east by the Kalugalkanda Crown forest and lot 4,555 in preliminary plan 2,566; south by dola, Kospelawatta belonging to L. Punchi Baba, Epitawatta belonging to B. Janda, land appearing in title plan 145,796, Memanamullawatta belonging to A. Punchi Appu and others, lands in title plans 145,785, 145,783, and 145,782, and lot V 254 in preliminary plan 2,565; west by footpath, Dianaittakumbura belonging to Don Dias, Henapolagewatta belonging to L. Malissa and others, Immawala belonging to Ahamado and others, footpath, Immawalawatta belonging to A. Mathes, and footpath—is the property of the Crown.
