NOTICES UNDER THE WASTE LANDS ORDINANCES.

[Notice under "The Waste Lands Ordinances, 1897, 1899, and 1900."]

TAKE notice, that unless within three months from the 18th day of September, 1900, the persons, if any, who claim any interest in the land hereinafter mentioned, appear before the Assistant Government Agent of the Kegalla District at the Kegalla Kachcheri and make claim to the said land or to some interest therein:

Such Assistant Government Agent, in pursuance of the powers in him vested by Ordinance No. 1 of 1897, shall declare by writing under his hand that the said land, as to which no claim has been made, is the property of the Crown.

Description of Land referred to.

P. 110,213 called Millagahamullahena claimed by Viyannalaye Sitti; on the east by land described on T. P. 110,213 called Millagahamullahena claimed by Viyannalage Sitti, and Wariyagodawatta (P. P. 483) claimed by Saibu Ismail Lebbe; on the south by

Paspolakanda and Batahenamukalana (^{P. P. 483}₂) claimed by the Crown ; on the west by Wedikanda-ela, a portion of the village boundary of Ragalkauda village, Paranewatta, Wellaboddewatta, and Wellagawawatta, all claimed by Wedikande Rankira.


