NOTICES UNDER THE WASTE LANDS ORDINANCES.

[Notice under "The Waste Lands Ordinances, 1897, 1899, and 1900."]

TAKE notice, that unless within three months from the 25th day of October, 1900, the persons, if any, who claim any interest in the lands hereinafter mentioned, appear before the Assistant Government Agent of the Kegalla District, at the Kegalla Kachcheri, and make claim to the said lands or any of them or to some interest therein :

Such Assistant Government Agent, in pursuance of the powers in him vested by Ordinance No. 1 of 1897, shall declare by writing under his hand that the said lands or such of them, as to which no claim has been made, are the property of the Crown.


