NOTICES UNDER THE WASTE LANDS ORDINANCES.

[Notice under "The Waste Lands Ordinances, 1897, 1899, and 1900."]

TAKE notice, that unless within three months from 25th October, 1900, the persons, if any, who claim any interest in the lands hereinafter mentioned or in any one or more of such lands, appear before the Assistant Government Agent of the Kegalla District at the Kegalla Kachcheri and make claim to the said lands or any of them or to some interest therein :

Such Assistant Government Agent, in pursuance of the powers vested in him by Ordinance No. 1 of 1897, shall declare by writing under his hand that the said lands or such of them, as to which no claim has been made, are the property of the Crown.

on preliminary plan 205 ; bounded on the north by Hewanmaddehena claimed by D. Mudiyanseelage Dingiri Appuhami, Mepandurayalahena claimed by D. Kalu Banda and others, Pussahena claimed by D. Kalu Banda and others, Pussehen claimed by D. M. Dingiri Menika, Monaragalahena claimed by the Crown, and the village boundary of Talewala village ; on the east by Gallanamullahena claimed by D. M. Dingiri Appuhami and others, Dematagodahena claimed by D. Kirihatana and others, Kaludiyawalahena claimed by Kaludurayage Ukkumale and others, Budahitiya-ela ; on the south by Gurugoda-oya ; on the west by Wellatuduwehena claimed by D. Mudiyanse and others, Kanamiyabendahena claimed by Illendari-padige Horatala and others, Hewanmaddehena claimed by Mudiyanse and others.

Lot J 29 on preliminary plan 199 called Kandagawamukalana, in extent 5 acres 1 rood and 30 perches ; and bounded on the north by Gurugoda-oya and a footpath ; on the east by Kandagamadeniya claimed by K. PUNCHIRALA and Liyangahahena claimed by K. PUNCHIRALA and a stream ; on the south by Ambagahahena claimed by Waturalaye PUNCHA ; on the west by land appearing on title plan 157,799 called Kandagawa and Hulanhikgahamullamukalanawatta claimed by the proprietor of Hunugala estate.
