NOTICES UNDER THE WASTE LANDS ORDINANCES.

[Notice under "The Waste Lands Ordinances, 1897, 1899, and 1900."]

TAKE notice, that unless within three months from the 8th day of November, 1900, the persons, if any, who claim any interest in the lands hereinafter mentioned or in any one or more of such lauds, appear before the Special Officer appointed under section 23 of Ordinance No. 1 of 1897 at his office at Matara and make claim to the said lands or any of them or to some interest therein :

Such Special Officer, in pursuance of the powers vested in him by Ordinance No. 1 of 1897, will declare by writing under his hand that the said lands or such of them, as to which no claim has been made, are the property of the Crown.

Description of Lands referred to.

I.

The land commonly called or known as Appuwanagewattahena, Udawattahena, Ambagahadeniyagawahena, Agalaudagahalangahena, Wijeriyagekumburagawahena, and Udagedarakumburalangahena, situate in the village of Kotapola in the Morowak-korale of the Matara District, in the Southern Province, containing in extent 51 acres 3 roods and 12 perches, shown as lot 100 in sheet O 15/2, 10, as described in the annexed certified tracing therefrom, and bounded as follows : on the north by the Nilwala-ganga, Keselwattadeniyehena belonging to Crown, Keselwattadeniya sold by Crown to W. Don Andris (T. P. 155,807), and Keselwattadeniyahena belonging to Crown ; on the east by Gonuttawehena belonging to Crown ; on the south by Kekungahaliyadda belonging to Mantrige Adiriyana and others, Halambagahakumbura sold by Crown to K. Mathes-hami (T. P. 109,939), Wijeriyakumbura belonging to Mantrige Adiriyana and others, Kapatenuma belonging to Rupuge Adiriyana and others, Kotapolakurunduwatta sold by Crown to E. A. Panikkala (T. P. 65,732), and Kotapolakurunduwatta sold by Crown to A. Baban or Andiris (T. P. 65,731) ; on the west by Agalaudagahaokanda belonging to Mantrige Adiriyana and others, Udagedarakumbura belonging to Mantrige Loku Naide and others, Warallegewatta belonging to ditto, Badalgewattadeniya belonging to ditto, Badalgewatta belonging to ditto, Kapatenuma belonging to ditto, the Nilwala-ganga, and Egodawatta belonging to Mantrige Loku Naide and others.

[NOTE.—Lot 90 Kapatenuma, in extent 16 perches, possessed by Mantrige Loku Naide within these boundaries is excluded from this notice. The extent of 16 perches is not included in acreage of 51 acres 3 roods and 12 perches given above.]

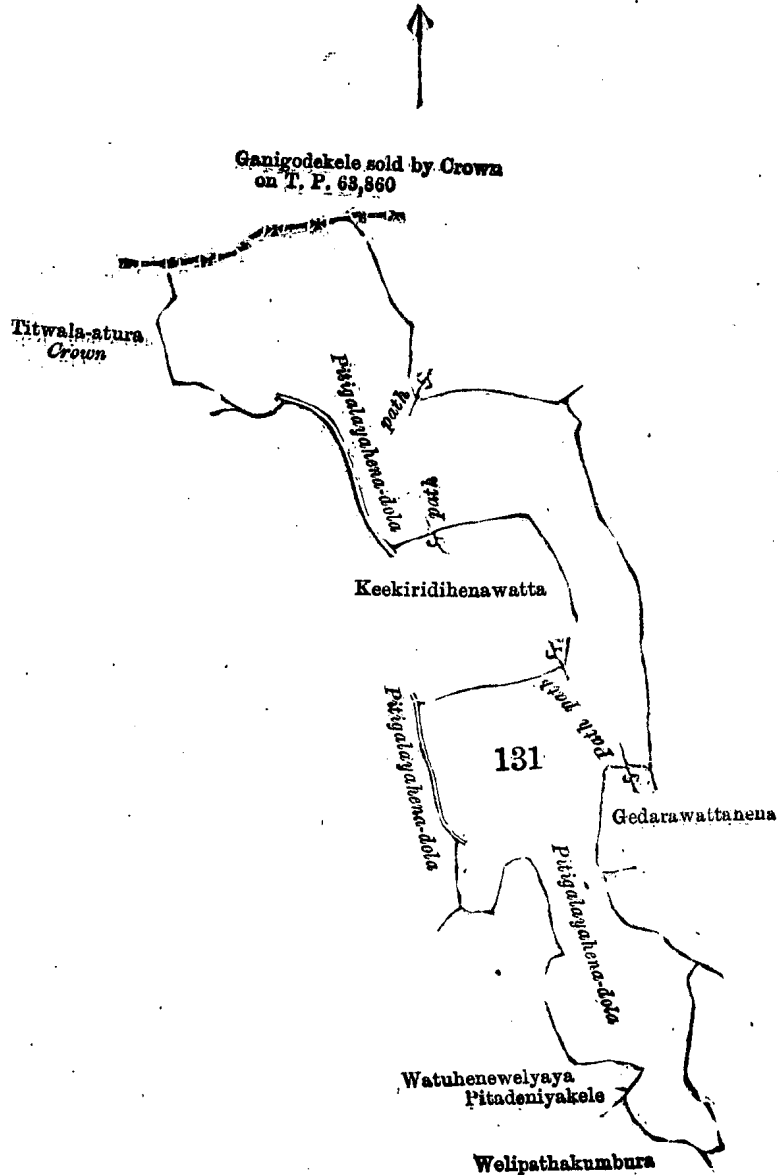
