NOTICES UNDER THE WASTE LANDS ORDINANCES.

[Notice under "The Waste Lands Ordinances, 1897, 1899, and 1900."]

TAKE notice, that unless within three months from the 15th day of December, 1900, the persons, if any, who claim any interest in the lands hereinafter mentioned or in any one or more of such lands, appear before the Assistant Government Agent of the Kegalla District at the Kegalla Kachcheri and make claim to the said lands or any of them or to some interest therein :

Such Assistant Government Agent, in pursuance of the powers vested in him by Ordinance No. 1 of 1897 will declare by writing under his hand that the said lands or such of them, as to which no claim has been made, are the property of the Crown.

Description of Lands referred to.

The following lots, all situated in the village Undugoda in Kanduhaha pattuwa of Paranakuru korale, in the Kegalla District, as described in the annexed plan :-

- 1. Lot 49 on preliminary plan 33 called Latuwellahenamukalana, in extent 1 acre 1 rood and 20 perches; and bounded on the north by Puwakgahahena-ela; on the east and south by a stream reservation; west by the korale boundary of Beligal korale and Latuwellamukalana claimed by the Crown.
2. Lot 50 on preliminary plan 33 called Dombanemukalana, in extent 54 acres 1 rood and 14 perches; and bounded as follows: on the north by the village boundary of Moradana village; east by Puwakgahahena (P.P. 33/T 7) claimed by Vidanalage Mudiyanse and others; south by Katurugolla claimed by Sodaliyandi, Harassahena claimed by the Crown, Puwakgahahena (P.P. 33/T 7) claimed by Ekanayaka-achillage Dingiri Appuhamy, Okeiyagalahena (P.P. 33/J 8) claimed by Appuwa and others, Puwakgahahena-ela, and the korale boundary of Beligal korale; west by the korale boundary of Beligal korale, Latuwellamukalana, and Dombanakanda claimed by the Crown.

Lot 51 on preliminary plan 33 called Hinnemukalana, in extent 5 acres 2 roods and 29 perches; and bounded on the north by Nayahena claimed by Udagerallage Appuhamy; east by Harankahahena claimed by Henekarallage Siyatu and others, Hunukotuellaehena claimed by Narasinga-achillage Menikrala, Harankahahena claimed by Ranapatiyalage Kira, Wategahahena claimed by Radageappuwa and others; south by Madugahahena claimed by Ekanayaka-achillage Jotihamy; west by Hinahena claimed by Radage Kudahenaya and Sipalagewatta claimed by Paranakuruge Balahamy.

Lot 6,562 on preliminary plan 8,521 called Ettinniwetichchihena, in extent 13 acres 2 roods and 10 perches; and bounded on the north by Hunukotallohena claimed by Narasinga-achillage Menikrala, land described on title plan 145,365 called Dewalahena claimed by W. P. Fernando; on the east by a stream reservation; south by Wewaladeniya claimed by Ekanayaka-achillage Appuhamy and others, and Ettinniwetichchihena (P.P. 8,521/6,564) claimed by the Crown; west by Dikdeniya claimed by Ekanayaka-achillage Dingiri Appuhamy, Dikdeniyakumbura claimed by Waturevidanalage Mudiyanse and others, Dikdeniya claimed by Ekanayaka-achillage Appuhamy and others, Wategahahena claimed by Ranapatiyalage Kira and others, Harankahahena claimed by Henekarallage Siyatu and others, and Harankahahena claimed by Ranapatiyalage Kira.
5. Lot 6,564 on preliminary plan 8,521 called Ettinniwetichchihena, in extent 7 acres 1 rood and 6 perches; and bounded on the north by Wewaladeniya claimed by Ekanayaka-achillage Appuhamy and others and Ettinniwetichchihena (P.P. 8,521/6,562) claimed by the Crown; east by a stream reservation; south by Parawalatennakumbura claimed by Warakapolage Dingiri Appu; west by land described on title plan 155,581 called Kalagahamulahena or Undugoda estate claimed by Messrs. T. N. and J. Orchard and Udadikdeniya claimed by Waturevidanalage Mudiyanse and others.

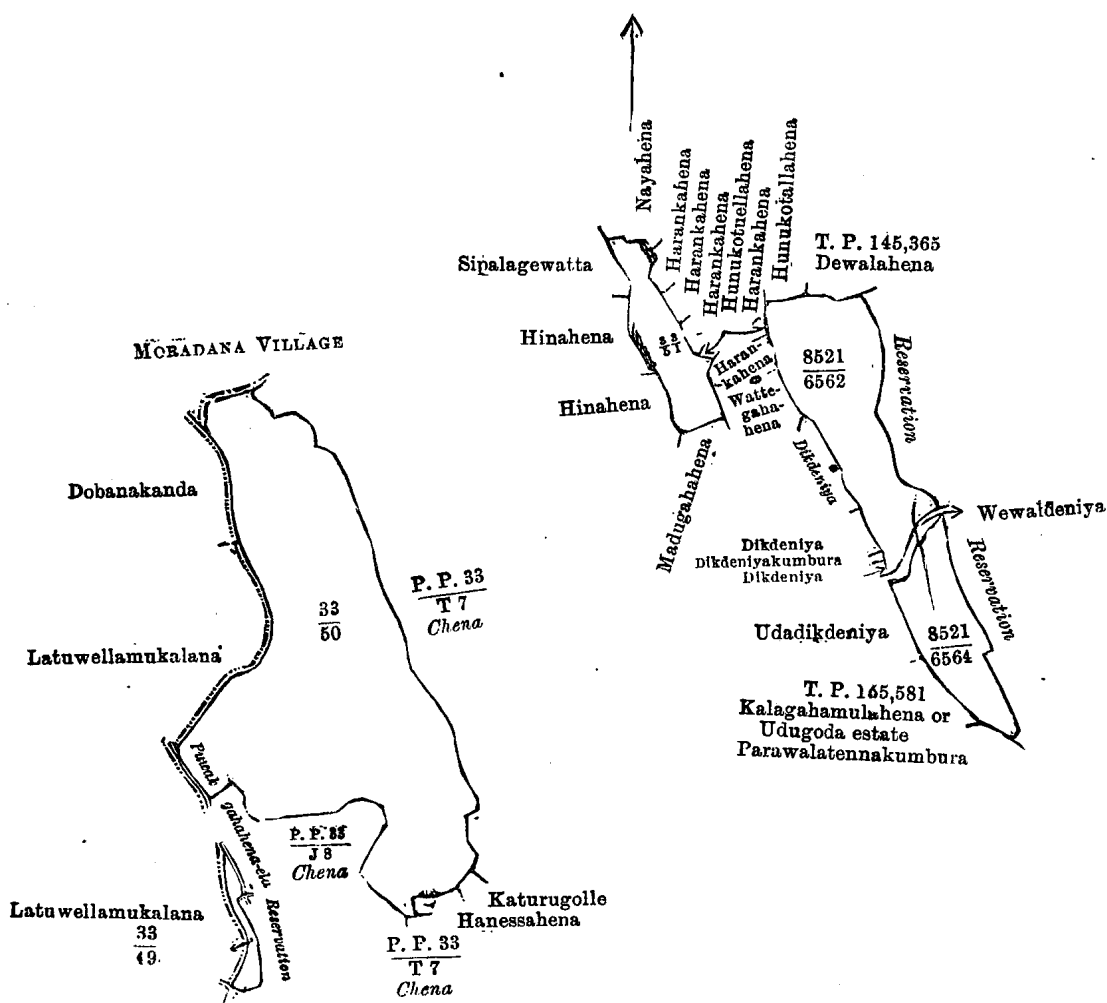
