NOTICES UNDER THE WASTE LANDS ORDINANCES.

[Notice under "The Waste Lands Ordinances, 1897, 1899, and 1900."]

TAKE notice, that unless within three months from the 7th day of December, 1900, the persons, if any, who claim any interest in the lands hereinafter mentioned or in any one or more of such lands, appear before me at the Galle Kachcheri and make claim to the said lands or any of them or to some interest therein:

I, George Merrick Fowler, the Government Agent of the Southern Province, in pursuance of the powers in me vested by Ordinance No. 1 of 1897, will declare by writing under my hand that the said lands or such of them, as to which no claim has been made, are the property of the Crown.

Description of Lands referred to.


The lands commonly called or known as Dihigahagoipola, Wamatwellalekaratura, Koholapitiyamanana, Wamatwellale, Uramalahena, Ginidelmananadeniya, Gongkanda, Dangaragahaudumulla, Kosgahagoipoladeniya, Kosgahagoipolakele, Kosgahagoipolakaratura, Dangaragahaudumulladuwa, Dangaragahaudumullamanana, Mahagangodaowita, and Iriyagahamulladeniya, situate in the village of Godagama in Wellaboda patta in the District of Galle, Southern Province, containing in extent 464 acres 2 roods and 8 perches, shown as lots 122, 182 to 186, 188, 196, 196, 199 to 204, 210 to 212, 223, 225, and 233, as described in the annexed plan, and bounded as follows: on the north by lands described in title plans Nos. 149,455 and 149,454, minor road from Batapola to Baddegama, and land described in title plan No. 144,995; on the east by lands described in title plans Nos. 162,638 and 162,641, Ginidelmananakumbura, lands described in title plans Nos. 155,621, 155,620, and 161,892, Satadombagahawatta, Dulva-addarakumbura, Uramalahenadeniya, and land described in title plan No. 160,790; on the south by lands described in title plans Nos. 144,841 and 144,626, Pansellawatta, Delgahawatta, Delgahawattakaratura, Delgahawattaddara, and lands described in title plan No. 58,281; and on the west by Mahagangodaya and the land described in title plan No. 152,785.

NOTE.—The following lot lying within the above-named boundaries is excluded from this notice, and its aggregate acreage 1 acre and 32 perches is not included in the acreage of 464 acres 2 roods and 8 perches given above:—
