[Notice under "The Waste Lands Ordinances, 1897, 1899, and 1900."]

TAKE notice, that unless within three months from the 21st day of December, 1900, the persons, if any, who claim any interest in the lands hereinafter mentioned or in any one or more of such lands, appear before the Special Officer appointed under section 28 of Ordinance No. 1 of 1897 at his office at Matara and make claim to the said lands or any of them, or to some interest therein :

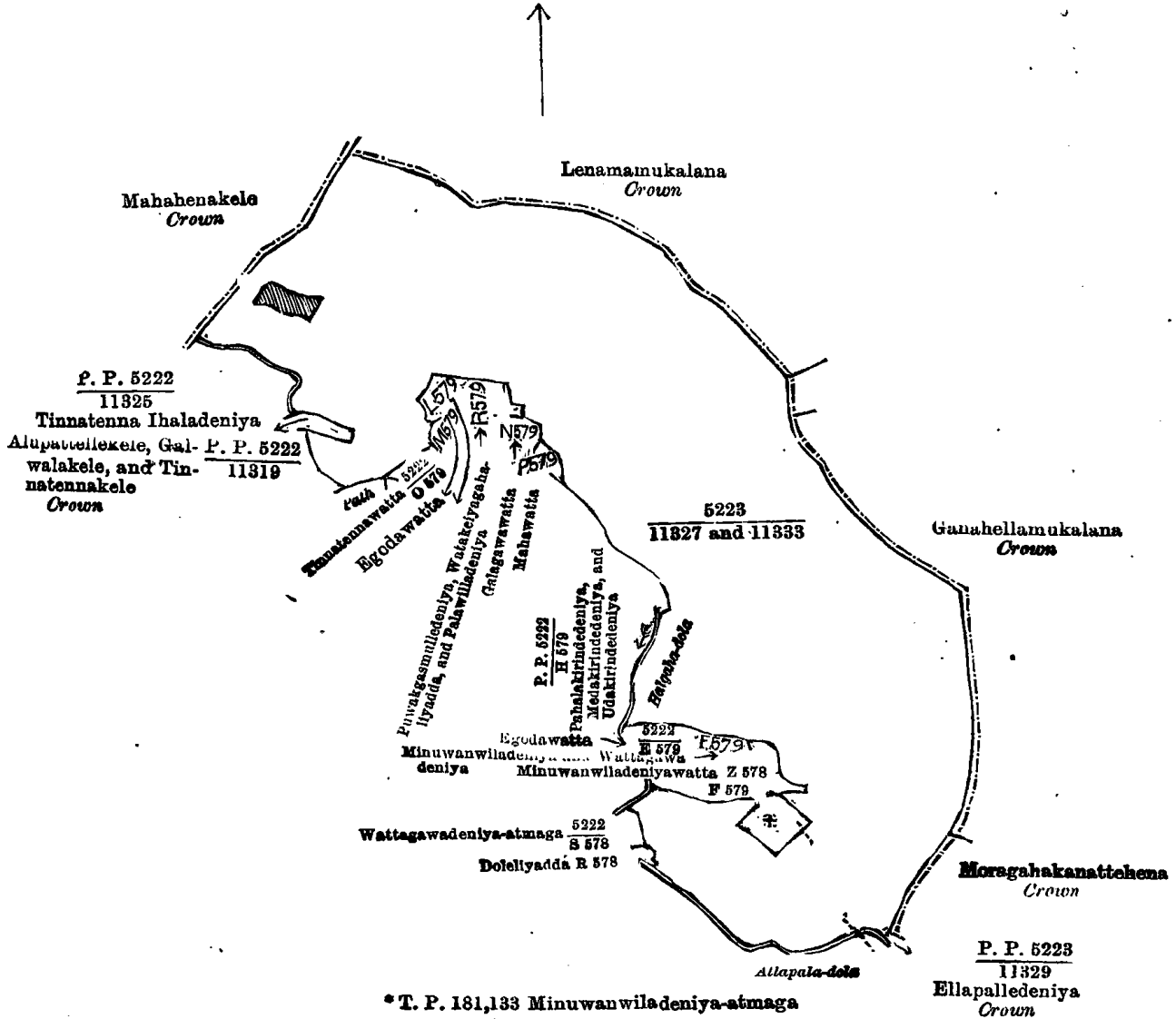
