NOTICES UNDER THE WASTE LANDS ORDINANCES.

[Notice under Ordinances No. 1 of 1897 and No. 5 of 1900.]

TAKE notice, that unless within three months from the 14th day of January, 1901, the persons, if any, who claim any interest in the land hereinafter mentioned, appear before me at Chilaw Kachcheri and make claim to the said land or to some interest therein:

I, John George Fraser, Assistant Government Agent of the Chilaw District of the North-Western Province, in pursuance of the powers in me vested by Ordinances No. 1 of 1897 and No. 5 of 1900, will declare by writing under my hand that the said land, to which no claim has been made, is the property of the Crown.

Description of Land referred to.

The land commonly called or known as Mugunuwatawana Pansalewatta, situate in the village of Mugunuwatawana in Munnessaram patti in Pitigal korale north in the Chilaw District, in the North-Western Province, containing in extent 10 acres 1 rood and 20 perches, as described in the annexed plan shown as lot G 646, and bounded as follows : on the north by Crown jungle called Parappamullakele ; east by Kelewila and footpath leading from Unagaswila ; south by field called Unagaswila and the land planted by vihare called Pansalewatta ; and west by the pansala and the road to Parappamulla.



வடமேற்கு மாகாணத்துக்குரிய சிலாப டிஸ்திரிக்கூச்சேர்ந்த வடக்கு பிற்றிகல்கோறலோக குச்சேர்ந்த முன்னேசரம் பற்றிச்சிருக்கும் முகுஞுவட்டவன் என்னும் குறிச்சியில் பெருமபா அம முகுஞுவட்டவன் பான்சாலவத்தை என்னும் காணியின் விசாலம 10 ஏக்கர் 1 மூட 20 பேர் சலை, இந்தக்காணியின் படம் இத்துடன் அணைக்கப்படும் படத்தில் G 646 நொம்பராக காட்டப் பட்டிருக்குது. இதன் எல்லைகளாவது : வடக்கு-முடிக்குரிய பரப்பமுள்ளகலே என்னும் காட்டுக்காணி ; கிழக்கு-கெவில்வெலவும் உனகஸ்வெல என்னும் இடத்திலிருந்துபோகும் அடிப்பாதை ; தெற்கு-உனகஸ்வெல என்னும் வயலும் பான்சாலவத்தை என்று சொல்லப்படும் விகாரையின் கணக்கில் உண்டுபண்ணப்படும் காணியும் ; மேற்கு-பான்சாலையும் பரப்பமுள்ளொக்குபோகும் வழியும்.
