NOTICES UNDER THE WASTE LANDS ORDINANCES.

[Notice under "The Waste Lands Ordinances, 1897, 1899, and 1900."]

TAKE notice, that unless within three months from the 9th day of February, 1901, the persons, if any, who claim any interest in the lands hereinafter mentioned or in any one or more of such lands, appear before the Assistant Government Agent of the Kegalla District at the Kegalla Kachcheri and make claim to the said lands or any of them or to some interest therein :

Such Assistant Government Agent, in pursuance of the powers vested in him by Ordinance No. 1 of 1897, will declare by writing under his hand that the said lands or such of them, as to which no claim has been made, are the property of the Crown.

Charles Sinno ; east by a water-course, land described on T. P. 167,916 called Pallemullewatta claimed by K. A. Punchi Arachchia, a portion of Kahaliyadde-ela, Hapugahawalagawahena claimed by Punchi Arachchi, Etambagahamulahena claimed by T. Arachchi and another, Batapotaellahena claimed by Kiri Baiyiya, Batapotellahena claimed by P. Punchi Arachchi, and Vegalahena claimed by Puncha ; south by a portion of Kahaliyadde-ela and Kosgollawatta claimed by Ukkuwa ; west by Galendahena claimed by Punchi Arachchi, Bulugahamulahena claimed by Ukkuwa, Kahatagahamulahena claimed by Tikiri Arachchi, Waggalahena claimed by Kiri Baiyiya, land described on T. 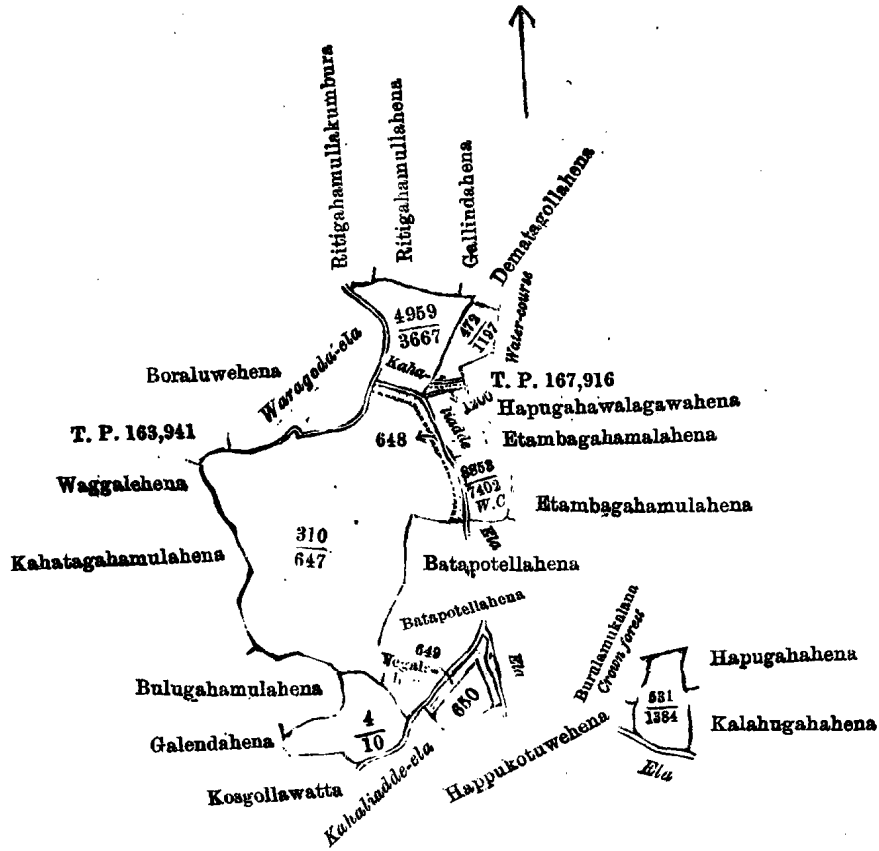
