**NOTICES UNDER THE WASTE LANDS ORDINANCES.**

[Notice under "The Waste Lands Ordinances, 1897, 1899, and 1900."]

**T**AKE notice, that unless within three months from the 23rd day of February, 1901, the persons, if any, who claim any interest in the lands hereinafter mentioned or in any one or more of such lands, appear before the Assistant Government Agent of the Kegalla District at the Kegalla Kachcheri and make claim to the said lands or any of them or to some interest therein :

Such Assistant Government Agent, in pursuance of the powers vested in him by Ordinance No. 1 of 1897, will declare by writing under his hand that the said lands or such of them, as to which no claim has been made, are the property of the Crown.

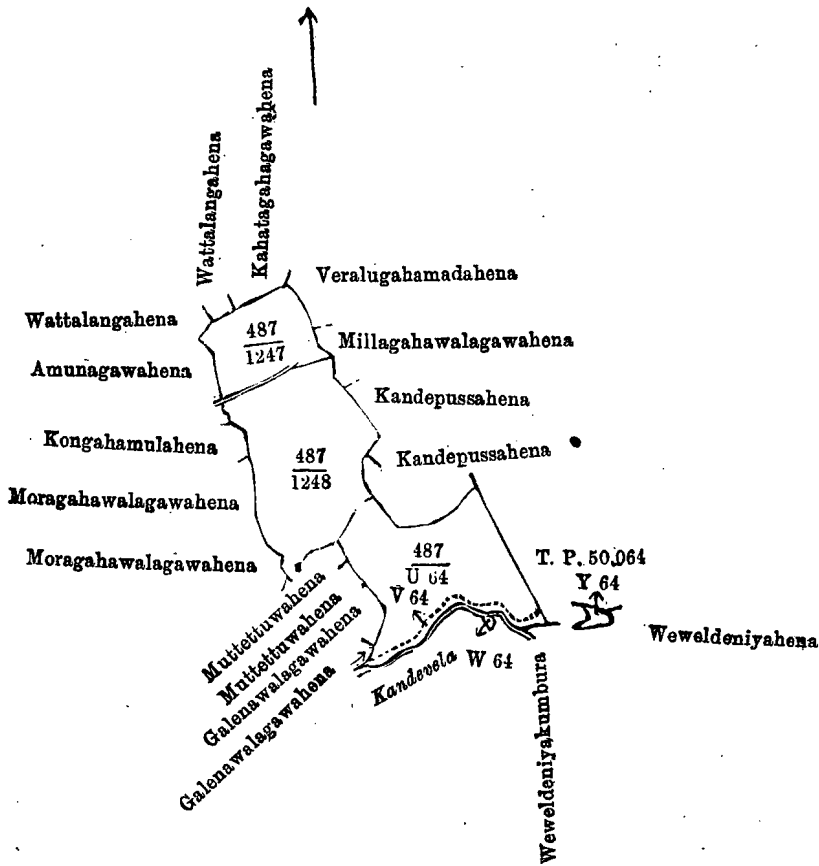
