NOTICES UNDER THE WASTE LANDS ORDINANCES.

[Notice under "The Waste Lands Ordinances, 1897, 1899, and 1900."]

TAKE notice, that unless within three months from the 29th day of March, 1901, the persons, if any, who claim any interest in the lands hereinafter mentioned or in any one or more of such lands, appear before the Special Officer appointed under section 28 of Ordinance No. 1 of 1897 at his office at Matara and make claim to the said lands or any of them or to some interest therein :

Such Special Officer, in pursuance of the powers vested in him by Ordinance No. 1 of 1897, will declare by writing under his hand that the said lands or such of them, as to which no claim has been made, are the property of the Crown.






