NOTICES UNDER THE WASTE LANDS ORDINANCES.

[Notice under "The Waste Lands Ordinances, 1897, 1899, and 1900."]

TAKE notice, that unless within three months from the 10th day of April, 1901, the persons, if any, who claim any interest in the land hereinafter mentioned, appear before the Government Agent of the Province of Sabaragamuwa at the Ratnapura Kachcheri and make claim to the said lands or to some interest therein :

Such Government Agent, in pursuance of the powers in him vested by Ordinance No. 1 of 1897, will declare by writing under his hand that the said land, to which no claim has been made, is the property of the Crown.

Description of Land referred to.

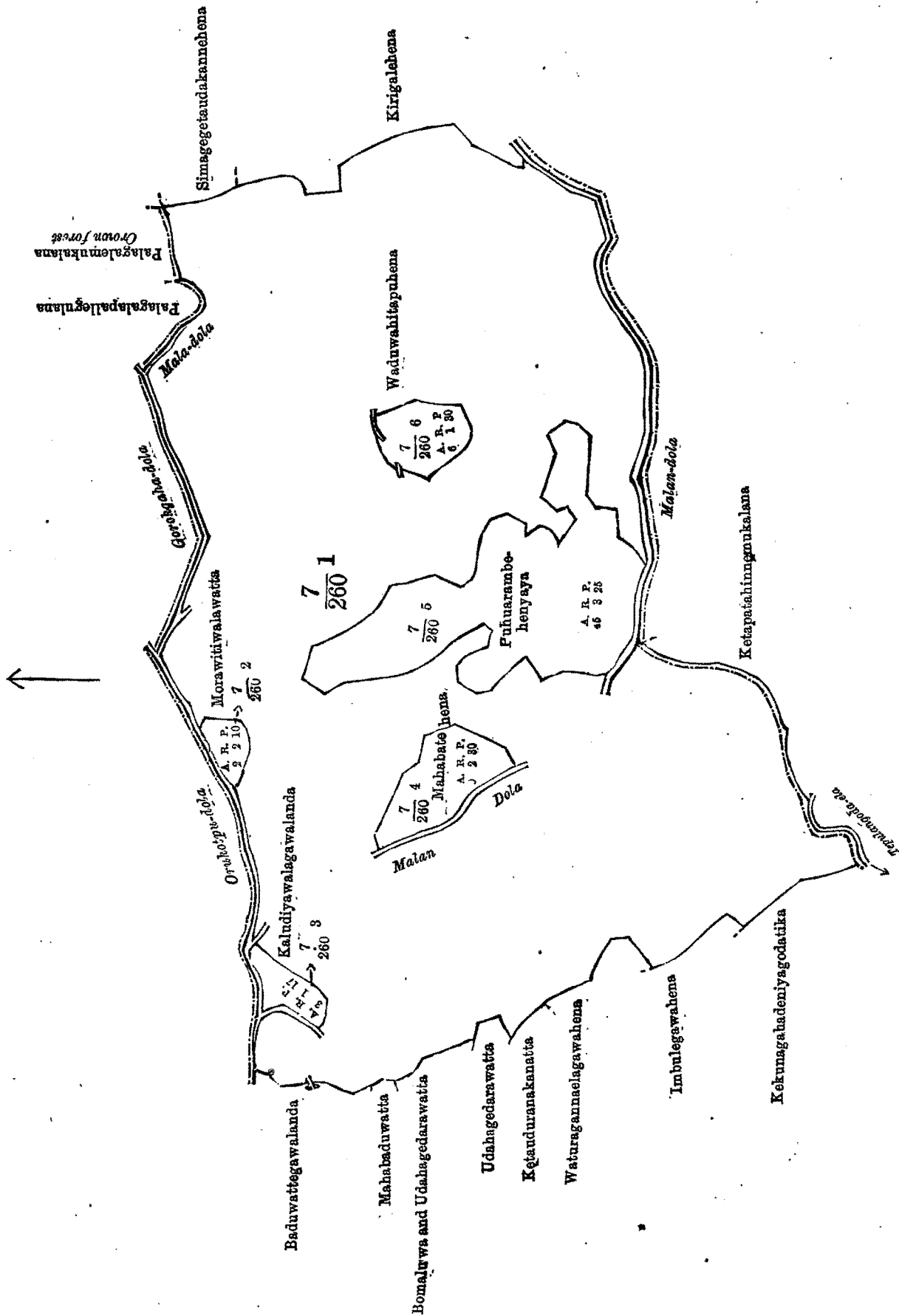
Land lot No. 1 in plan of survey No. $\frac{7}{260}$ called Malankelemukalana, situate in the village of Malangama in the Uda pattuwa of the Kuruwiti korale in the District of Ratnapura, in the Province of Sabaragamuwa, containing in extent 433 acres 3 roods, as described in the annexed plan, and bounded as follows : on the north by Orukatpudola, Gorokgahadola, Maladola, Palagalapallegulana claimed by M. Siribohamy and others, Palagalamukalana Crown forest ; on the east by Simagegetandakannehena claimed by M. Siribohamy, Kirigalahena claimed by M. Siribohamy and others, and Malandola ; on the south by Malandola, Ketapatahinnekulana claimed by T. M. Punchimahatmaya and others, and Tepulangoda-ela ; on the west by lands called Kekunagahadeniyagodatika, Imbulegawahena, Waturagaunnaelagawahena claimed by M. Siribohamy and others, Ketauturanakanatta claimed by G. A. Gunahamy, Udahagedarawatta claimed by P. A. Punchirala, Bomaluwa and Udahagedarawatta claimed by K. M. Punchimahatmaya, Mahabaduwatta claimed by T. M. Rattrahamy, Baduwatta gawalanda claimed by M. Siribohamy and others.
