NOTICES UNDER THE WASTE LANDS ORDINANCES.

[Notice under "The Waste Lands Ordinances, 1897, 1899, and 1900."]

TAKE notice, that unless within three months from the 22nd day of July, 1901, the persons, if any, who claim any interest in the lands hereinafter mentioned or in any one or more of such lands, appear before the Hon. the Government Agent of the Western Province at the Colombo Kachcheri and make claim to the said lands or any of them or to some interest therein :

Such Government Agent, in pursuance of the powers in him vested by Ordinance No. 1 of 1897, will declare by writing under his hand that the said lands or such of them, to which no claim has been made, are the property of the Crown.

List of lands referred to above, situated in the village Pingamuwa in Gangaboda pattu of Siyane korale east, in the District of Colombo of the Western Province, as shown in plan No. 22 annexed.

1. Lot 1 known as Kudumbekandekale, containing in extent 41 acres ; bounded on the north by the boundary of the village Bopagama ; on the east by land described in title plan No. 124,262, lot A 1 called Kinagahahawatta the property of Kudamahaloluwage Thepanis Appu and others, land described in title plan No 124,156, lot A 2 called Kinagahawatta sold to Kudamahaloluwage Thepanis Appu and Don Siman Police Vidane ; on the south by lot B called Moragahahawatta the property of Ratnayakege Welon Appu and others ; and on the west by lot E called Moragahahena sold to Hehatpurahakuruge Davitha and Thegrisa, lot D called Moragahahena sold to Manchanayaka Appuhamilage Gregoris Appuhamy, lot B called Moragahawatta the property of Ratnayakege Welon Appu and others, land described in title plan No. 65,448 and lots B 1, B 3, B 2, B 1 called Moragahawatta the property of Ratnayakege Welon Appu and others.

2. Lot No. 9 known as Millalandemukalana, containing in extent 12 acres 2 roods 10 perches ; bounded on the north by lot A 1 1/2 called Hirigolleowita sold to Don Abraham Wijesinha ; on the east by land described in title plan No. 133,774, and the boundary of the village Kendagolla ; on the south by lot 11 called Alubogahahena sold to the Maha Mudaliyar S. D. Bandaranayaka ; and on the west by lot 8 called Millagahalanda sold to the Maha Mudaliyar S. D. Bandaranayaka, lot D 1 called Delgahawatta the property of Hehatpurahakuruge Podia and Dilla, and lot E 1 called Gorakagahawatta the property of Welagoda-achchige Sedris Appu and Kariyawasan Wickrama-achchige Babasinno.

D. Bandaranayaka ; on the east by the boundary of the village Kendagolla ; on the south by the boundaries of the villages Kendagolla and Narangaspitiya ; and on the west by lot P 1 called Talgaswattakumbura claimed by Dahanaikeachchige Peris Appu and O 1 called Kosgahawatta sold to Galapatage Mudalihami, land described in title plan No. 166,263, lot S called Talgaswattakumbura and Kelagaskumbura claimed by D. B. Wijeyesinghe and others, lot N 1 called Millagahawatta the property of Handiragama Kankanange Danohami, and lot 11 called Alubogahahena sold to Maha Mudaliyar S. D. Bandaranayaka.

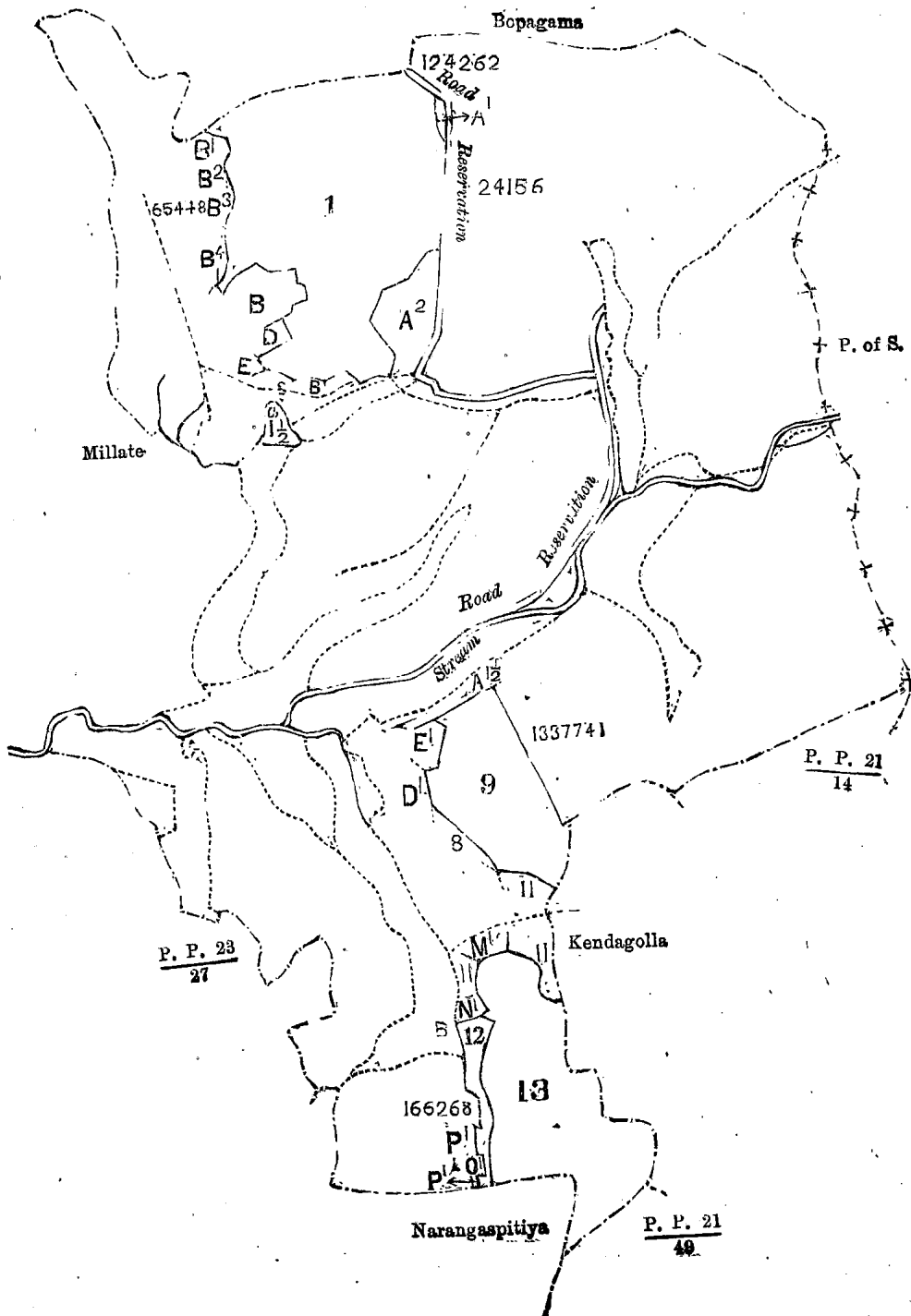
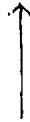
