NOTICES UNDER THE WASTE LANDS ORDINANCES.

[Notice under Section 1 of Ordinance No. 1 of 1897, "An Ordinance relating to Claims to Forest, Chena, Waste, and Unoccupied Lands."]


TAKE notice, that unless within three months from the 15th day of July, 1901, being the date of this notice, the persons, if any, who claim any interest in the land commonly called or known as Galkandepatana, &c., and Kirindebedde and Gollekandepatana, situated in the village of Hinnarangolla in the Dehiwinipalata korale of Udukinda, in the Province of Uva, containing in extent 180 acres 2 rods and 15 perches, and bounded as follows : east and north by road to Badulla, a stream, Dulgollewakahena claimed by H. Appu and others, a stream, land on T.P. 57,661, a stream, a road, a stream, and Bokkeareawehena claimed by M. Siyatu and others; west by road to Badulla, Dandugolle claimed by Hendrick Appu and others, Dandugollehena claimed by Hendrick Appu and others, Hivalewagurawatta, &c., claimed by Hendrick Appu and others, Pinarawehena claimed by D. Dingirimenika and others, and a path ; south by a path, a water-course, and Kirindebedde and Gollekandepatana claimed by the Crown, appear before me at the Badulla Kachcheri and make claim to the said land or to some interest therein :

I, George Algernon Baumgartner, Government Agent of the Province of Uva, in pursuance of the powers in me vested by Ordinance No. 1 of 1897, will on the 15th day of October, 1901, being the date on which this notice expires, declare by writing under my hand that the said land is the property of the Crown.
