NOTICES UNDER THE WASTE LANDS ORDINANCES.

[Notice under Section 1 of Ordinance No. 1 of 1897, "An Ordinance relating to Claims to Forest, Chena, Waste and Unoccupied Lands."]


TAKE notice, that unless with three months from the 15th day of July, 1901, being the date of this notice, the persons, if any, who claim any interest in the land commonly called or known as Bedde-ellepatana, Rilaelakanda, &c., Bedde-ellekele, Pitahaelle, &c., situated in the village of Welawela in the Dehiwinipalata korale of Udukinda, in the Province of Uva, containing in extent 225 acres 1 rood and 10 perches, and bounded as follows: on the north by Girambekandura, land on T. P. 59,731, road to Badulla and the Girambekandura; east by Crown patana, a stream; south by Totapaolakandura, Galarawehena claimed by Punchi Banda, Galarawehena claimed by Loku Banda and others, Galarawekumbura claimed by Punchi Banda; west by Udaturewatta claimed by PUNCHIRALA and others, Edandakandura, Edandagawehena claimed by K. Mudianse and others, a path, Hale-eletenna claimed by K. Mudianse and others, a path, encroachment made by owner of T. P. 51,425, Elakumbura-patana sold on T. P. 51,425, reservation for path, land sold on title plans 170,761 and 175,815, Walabedde-patana, and reservation, appear before me at the Badulla Kachcheri and make claim to the said land or to some interest therein:
