NOTICES UNDER THE WASTE LANDS ORDINANCES.

[Notice under "The Waste Lands Ordinances, 1897, 1899, and 1900."]

TAKE notice, that unless within three months from the 26th day of July, 1901, the persons, if any, who claim any interest in the lands hereinafter mentioned or in any one or more of such lands, appear before the Government Agent of the Province of Sabaragamuwa at the Ratnapura Kachcheri and make claim to the said lands or any of them or to some interest therein.

Such Government Agent, in pursuance of the powers in him vested by Ordinance No. 1 of 1897, will declare by writing under his hand that the said lands or such of them, as to which no claim has been made, are the property of the Crown.




