NOTICES UNDER THE WASTE LANDS ORDINANCES.

[Notice under Ordinance No. 1 of 1897.]

TAKE notice, that unless within three months from the 1st day of September, 1901, the persons, if any, who claim any interest in the land hereinafter mentioned, appear before me at the Hambantota Kachcheri and make claim to the said land or to some interest therein :

I, Benjamin Horsburgh, Assistant Government Agent of the Hambantota District, in pursuance of the powers in me vested by Ordinance No. 1 of 1897, shall declare by writing under my hand that the said land, to which no claim has been made, is the property of the Crown.

Description of the Land referred to.

Mahamagamukalana or Arakongahahena, situated in the village Gonadeniya in Giruwa pattu west of the Hambantota District, in the Southern Province, described in the annexed certified tracing as lot No. 8,993 in preliminary plan No.3,718; bounded on the north by Crown land called Mahamagamukalana described as $\frac{3,718}{8,992}$, on the east and south by Crown land $\frac{3,718}{8,992}$ called Wakandawewayaya described as $\frac{3,718}{8,994}$, and on the west by Crown land called Mahamagamukalana described as preliminary plan No. $\frac{3,718}{8,992}$; containing in extent 7 acres and 22 perches.


