NOTICES UNDER THE WASTE LANDS ORDINANCES.

[Notice under "The Waste Lands Ordinances, 1897, 1899, and 1900."]

TAKE notice, that unless within three months from the 15th day of September, 1901, the persons, if any, who claim any interest in the lands hereinafter mentioned, or in any one or more of such lands, appear before the Assistant Government Agent of the Puttalam District at the Puttalam Kacheheri and make claim to the said lands or any of them or to some interest therein :

Such Assistant Government Agent, in pursuance of the powers vested in him by Ordinances No. 1 of 1897, No. 1 of 1899, and No. 5 of 1900, will declare by writing under his hand that the said lands or such of them, as to which no claim has been made, are the property of the Crown.

Description of Lands referred to.

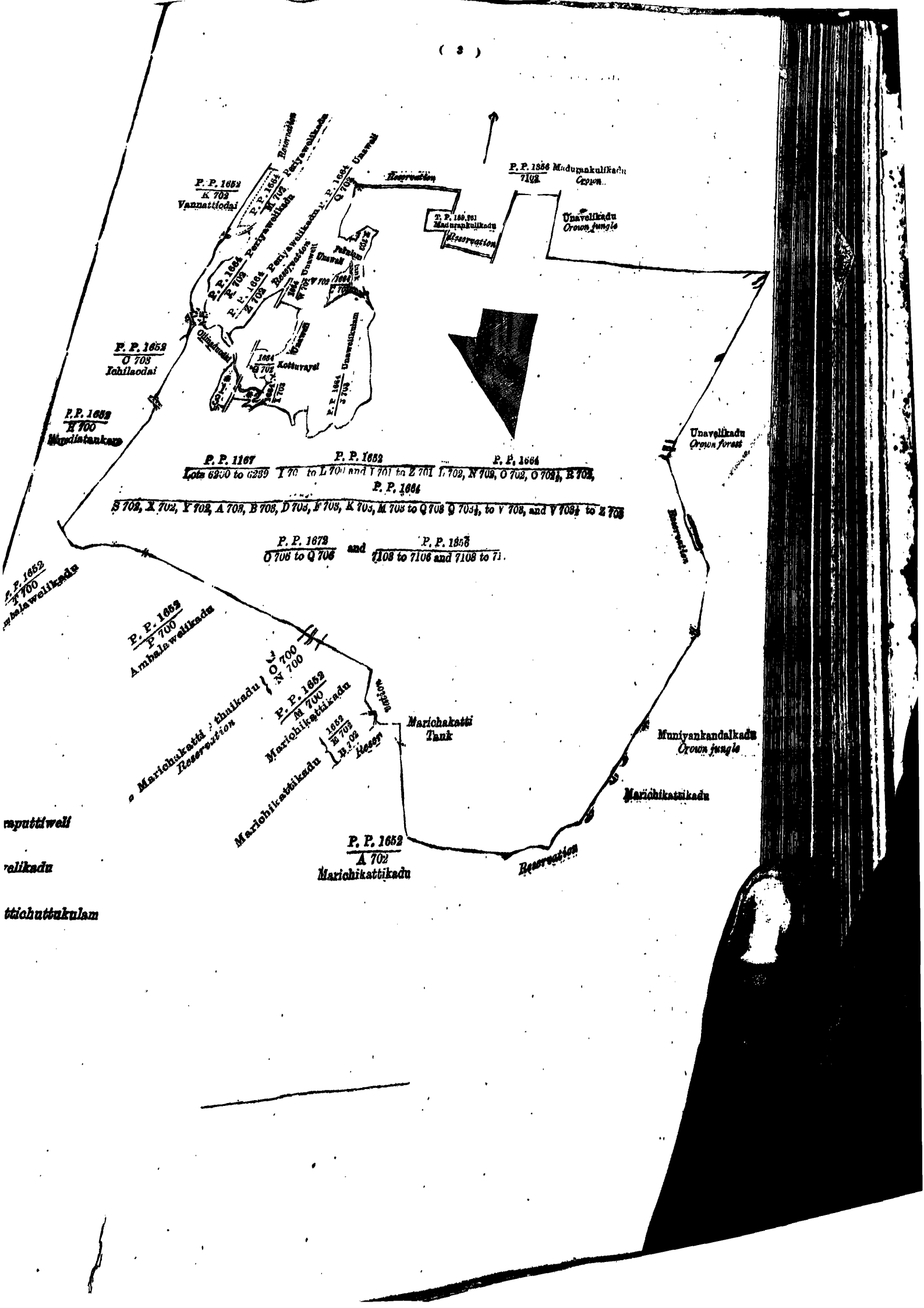
The land commonly called or known as Unavelikadu, situate in the village Unaveli in Puttalam pattu of the Puttalam pattu division in Puttalam District, North-Western Province, containing in extent 2,366 acres and 14 perches, shown as lots 6,200 to 6,239 in preliminary plan No. 1,167, lots 700 701 in preliminary plan No. 1,652, lots 702 703 703 1/2 in preliminary plan No. 1,664, lots 706 in preliminary plan No. 1,672, and lots 7,103 to 7,106 and 7,108 to 7,116 in preliminary plan No. 1,356, a certified tracing of the land is hereunto annexed, it is bounded as follows: north by reservation, Madurankulikadu in title plan No 159,261 purchased by N. M. P. Kasi Mohidin, Crown jungle Madurankulikadu, (lot 7,102 in preliminary plan No. 1,356), and Crown jungle Unavelikadu; south by lot A 702 Marichchikattikadu claimed by M. M. T. M Muttu Marikar with Mira Saib Marikar and reservation ; south-west by Ambalavelikadu (lot 700 P, T) and Marichchikatti- athaikadu (lots 700 M, N, O and 702 B, E in preliminary plan No. 1,652) claimed by M. M. T. M Muttu Marikar with Mira Saib Marikar and reservation ; east by Crown forest Unavelikadu, Crown jungle Muniyankandalkadu and Marichchikattikadu ; and on the west by Vannattiodal, (lot K 702) claimed by N. Mapala Tambi and fifty-five others, Ichilaodoi (lot C 703) claimed by N. Mapala Tambi and fifty-five others and M. M. T. M Muttu Marikar with Mira Saib Marikar, and Ichilavedi Atankara (lot H 700 in preliminary plan No. 1,652) claimed by N. Mapala Tambi with fifty-five others and M. M. T. M Muttu Marikar with Mira Saib Marikar.
