NOTICES UNDER THE WASTE LANDS ORDINANCES.

[Notice under Ordinance No. 1 of 1897.]

TAKE notice, that unless within three months from the 1st day of September, 1901, the persons, if any, who claim any interest in the land hereinafter mentioned, appear before me at the Hambantota Kachcheri and make claim to the said land or to some interest therein.

I, Benjamin Horsburgh, Assistant Government Agent of the Hambantota District, in pursuance of the powers in me vested by Ordinance No. 1 of 1897, shall declare by writing under my hand that the said land, to which no claim has been made is the property of the Crown.

P. No. $\frac{3,718}{8,986}$; bounded on the north by Crown land called Gonadeniyamukalana described as P. P. $\frac{3,718}{8,983}$; on the east by Crown land called Mahamagamukalana described as P. P. $\frac{3,718}{8,984}$; on the south by Crown land called Mahamaga- mukalana described as P. P. $\frac{3,718}{8,985}$; on the west by Crown land called Walagawahena described as P. P. $\frac{3,718}{8,987}$; containing in extent 19 acres.


