NOTICES UNDER THE WASTE LANDS ORDINANCES.

[Notice under Ordinance No. 1 of 1897.]

TAKE notice, that unless within three months from the 1st day of September, 1901, the persons, if any, who claim any interest in the land hereinafter mentioned, appear before me at the Hambantota Kachcheri and make claim to the said land or to some interest therein :

I, Benjamin Horsburgh, Assistant Government Agent of the Hambantota District, in pursuance of the powers in me vested by Ordinance No. 1 of 1897, shall declare by writing under my hand, that the said land, to which no claim has been made, is the property of the Crown.

Description of the Land referred to.

The land called Maragamanahena and cleared portion of Mahamagamukalana is situated in the village of Gonadeniya in the Giruwa patta west of the Hambantota District, in the Southern Province, as described in the annexed certified tracing lot No. 9,001 in preliminary plan 3,718; and bounded on the north by Crown land Mahamagamukalana described as (P. P. 3,718) ; east by footpath and reservation described as (P. P. 3,718) ; south by Crown land described as (P. P. 3,718) ; 8,984 ; and on the west by Crown land Mahamagamukalana described as (P. P. 3,718) and Mahamagamukalana belonging to Crown described as (P. P. 3,718) ; containing in extent 20 acres 2 roods 5 perches.


