NOTICES UNDER THE WASTE LANDS ORDINANCES.

[Notice under "The Waste Lands Ordinances, 1897, 1899, and 1900."]

*AKE notice, that unless within three months from the Twenty-eighth day of September, 1901, the persons, if any, who claim any interest in the lands hereinafter mentioned or in any one or more of such lands, appear before the Assistant Government Agent of the Kegalla District at the Kegalla Kachcheri and make claim to the said lands or any of them or to some interest therein:

Such Assistant Government Agent, in pursuance of the powers in him vested by Ordinance No. 1 of 1897, will declare by writing under his hand that the said lands or such of them, as to which no claim has been made, are the property of the Crown.

Description of Lands referred to.

Lot No. 9,330 on preliminary plan 4,152 called Kabaragala, in extent 218 acres, and bounded as follows: north by Hannagollemukalana claimed by the Crown, Kotakiriawehena claimed by Kapurallage Hamy and others, Panuambemulahena claimed by Kapurallage Vibadderala and others, Moragahamulahena and Kitulgollehena olaimed by Sandorage Menikrala Vedarala, Hunngalamulahena, Kandehenawatta, and Galinnawatta claimed by Perakotuwe Punchirala Vedarala and others, and a rock; east by Welbatemukalana claimed by the Crown; south by land described on T. P. 48,590 called Kandal-oya estate claimed by the Ceylon and Indian Planters' Association, Limited, a path, and a portion of land described on T. P. 45,945 called Weweltalawa estate claimed by the Consolidated Tea and Land Company, Limited; west by a portion of the land called Hanngollemukalana claimed by the Crown.
- 2. Lot 9,334 on preliminary plan 4,152 called Madampitiyakele, in extent 70 acres 2 roods and 20 perches, and bounded as follows: north by land described on T. P. 48,590 called Kandel-oya estate claimed by the Ceylon and Indian Planters' Association, Limited, and Tebuwatta-oya; east and south by Etunbessakadullemukalana claimed by the Crown; west by Kabaragalamukalana (P. P 4,152) claimed by the Crown.

Lot 7,735 on preliminary plan 5,984 called Gurulugollamukalana, in extent 5 acres 3 roods and 37 porches, and bounded as follows: north by Kandawattahena claimed by Perakotuwe Punchirala and others; east by Kosgala-ela, Gurulugollemukalana claimed by the Crown, Galendamukalana and Hapugahahena (P. 
