[Notice under "The Waste Lands Ordinances, 1897, 1899, and 1900."]

TAKE notice, that unless within three months from the 4th day of October, 1901, the persons, if any, who claim any interest in the land hereinafter mentioned, appear before the Special Officer appointed under section 28 of Ordinance No. 1 of 1897 at his office at Galle and make claim to the said land or to some interest therein :

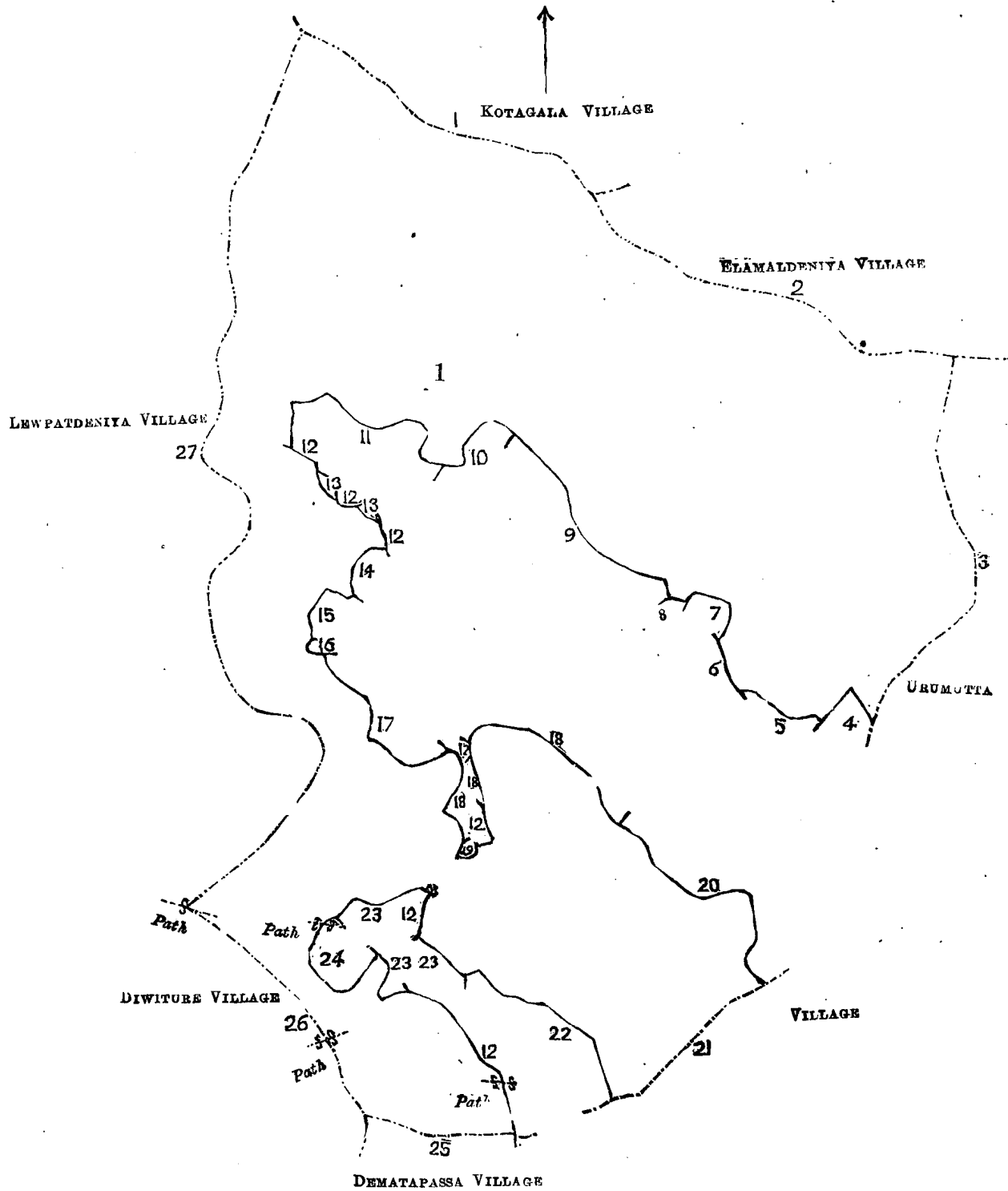
