NOTICES UNDER THE WASTE LANDS ORDINANCES.

[Notice under Ordinances No. 1 of 1897 and No. 5 of 1900.]

TAKE notice, that unless within three months from the 1st day of December, 1901, the persons, if any, who claim any interest in the lands hereinafter mentioned, appear before me at the Chilaw Kachcheri and make claim to the said lands or to some interest therein:

Description of Lands referred to.

The following lots, situated in the village Arachchikattuwa in Anaivulundan pattu in Pitigal korale north in the District of Chilaw, in the North-Western Province, as described in the annexed plan :—

Lots 18 and 19 shown on plan S.G.O. ²⁵_{N.W.P.}, called or known as Pahalakele, in extent 360 acres 2 roods and 15 perches; and bounded on the north by Sengaloya; east by road from Putalam to Colombo, land claimed by J. P. Fernando on title plan 180,247, Crown land called Pahalakele, land claimed by Senanayeka Mulaige Hitihamy and others on title plans 159,624, 135,266, and 156,529; south by the limits of Rajakadaluwa and Kudamanaaweriya villages; and west by Crown land called Pahalakele and Vairankattuwā village.

Note.—The hachured block, the extent of which is 1 acre 2 rods and 20 perches, is not included in the acreage of 360 acres 2 rods and 15 perches.


