NOTICE UNDER ORDINANCE No. 1 OF 1897.

[An Ordinance relating to Claims to Forest, Chena, Waste, and Unoccupied Lands.]

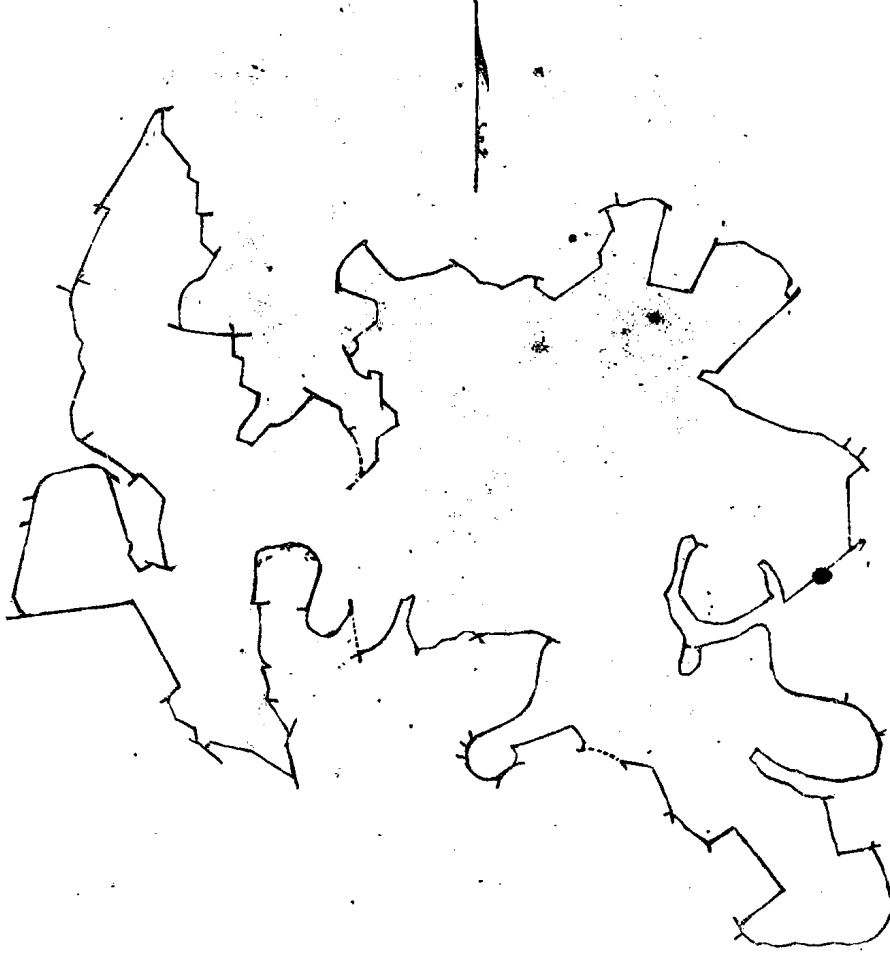
