MY LORD,—With reference to my Despatch No. 157, Commercial, of the 23rd of June last, I have the honour to inform Your Lordship that after being duly voted by the Chamber of Deputies on the 22nd of June last, the Senate yesterday unanimously adopted the Commercial Conventions which have been signed between Great Britain and France with regard to India, Ceylon, the Seychelles, and East and Central Africa, and Uganda.

Storey of Warakamure estate, Matale, on behalf of Mr. Robert Holme Storey of Lancaster, County of Lancaster, and 9, Bentinck Mansions, Bentinck street, London, W., England, for the lease of Nadu Tivu, an island in the Mahaweli-ganga in the Meda pattu of the District of Tamankaduwa in the North-Central Province, in extent 669 acres 1 rood and 18 perches; and bounded on the north, south, and west by the Kalu-ganga, and on the east by the Mahaweli-ganga, for the purpose of experimental cultivation of coconuts, rubber, and fruits, and it being considered desirable to encourage such experimental cultivation which, if found to be successful, is likely to lead to the opening up for cultivation of similar unirrigable land in the District hitherto lying waste; It is hereby notified under Regulation No. 52 of Land Sale Regulations published in the *Gazette* dated February 20, 1903, that it is proposed to lease the said land to the said applicant under the following conditions, unless within six weeks from the date of this notice valid reasons to the contrary are adduced :—

1. The rent to be 50 cents per acre per annum.
2. The lease of the land to be for 6 years with the option of purchase at Rs. 10 per acre at the end of that period.
3. Coconuts, rubber, and fruit only to be planted on the land leased.
4. The Forest Department to be at liberty to fell and remove all the timber on the land which it considers it worth while to deal with in that manner, and the lessee to deal as he likes with any other timber on the actual clearing in progress.

5. The land to be forfeited to, and vest in, the Crown, if at any time such land or any building thereon be applied, without the written consent of the Governor, to other purposes than those specified in the grant or lease, or if within a reasonable time the necessary steps have not been taken to apply the land to the purpose for which it was granted.

6. No permanent buildings to be erected on the land without the written consent of the Government Agent.

MISCELLANEOUS DEPARTMENTAL NOTICES.

CAMBRIDGE LOCAL EXAMINATIONS, 1904.

AN Examination of Senior and Junior Candidates, in accordance with the Regulations of the Revised Code, will be held at Colombo, Kandy, Galle, Jaffna, Batticaloa, and Kurunegala on December 12, 1904, and the following days.

2. Forms of entry duly filled up should be forwarded so as to reach the Director of Public Instruction not later than 4 P.M. on Thursday, August 4, 1904, together with the following fees, which should be paid as follows:—

(1) A Bank Draft on England payable to Dr. J. N. Keynes, crossed "Barclay & Co.," at the rate of £1 for each candidate, as the Cambridge fee.

N.B.—The fees should not under any circumstances be remitted by Money Order. *No cash, or Money Order, Bank Draft, or cheque in favour of the Director of Public Instruction will be accepted.*

(2) A Post Office Order (not Postal Order), Bank Draft, or crossed cheque in my favour at the rate of Rs. 2.50 for each candidate, as the local expenses fee. *Cash will not be accepted.*

N.B. Forms of entry will be accepted from August 5 to August 13 inclusive on payment of an extra fee of Rs. 5.

All entry forms received at the Public Instruction Office not accompanied by the Cambridge and Local fees, as well as the proper Birth-Certificate where one is required, will be immediately returned to the sender.

3. Forms of entry may be had from the Director in the second week in July. It is requested that Managers will only apply for such number of forms as they actually require, and that they will not encourage any student to enter as a candidate unless they are satisfied that he has a fair chance of passing the examination.

It is also requested that Principals of schools will check the entry forms of their candidates and see that the instructions of the Syndicate with regard to the filling up of the forms are complied with. *The date of birth should be carefully verified, and the candidates' full names must be given without any initials.*

4. Applications for entry forms should be made from the first week in July, 1904, stating what kinds of entry forms, C, D, E, or F, and the number of forms of each kind are required.

5. Religious Knowledge, as a subject of examination, is not necessary for Colonial Students, and no grant or award under the Revised Code will be made directly or indirectly dependent on marks gained for Religious Knowledge.

6. All under-age candidates must forward with their entry forms certificates of the registration of their birth, unless such a certificate has been sent to this office for a previous examination. Those who have already forwarded certificates of birth for a previous examination *should mention the year, the examination for which they forwarded the certificates, and the centre at which they appeared for the examination.* Affidavits will not be accepted *under any circumstances.*

A certificate of baptism should be a proper extract of the Baptismal Register, *i.e.*, an exact copy of the entry of the register should be made, and at the foot of the copy the incumbent of the Church issuing it should certify to its correctness.

Principals of Schools should examine carefully all certificates of birth or baptism, and should not forward any certificate which is not a reliable document.

7. Private students will only be admitted as under-age candidates if they forward, along with their entry form, a written statement from an Inspector of Schools that their certificate of birth or baptism is a reliable document.

N.B.—Baptismal certificates will only be accepted if the candidate's baptism was within four months of his date of birth; otherwise he will not be allowed to compete for Prizes and Scholarships.

8. Fees cannot be returned. If notice of withdrawal is received by the Local Secretary more than sixteen days before the commencement of the examination, a voucher will be sent, which will enable the student to enter in another year without further fee to the University, subject to the usual conditions of age. The Syndicate do not undertake to grant a similar voucher in any case in which the full sixteen days' notice has not been given. Applications made within sixteen days of the examination will, however, be considered if accompanied by a certificate from a qualified Doctor stating that the candidate is physically unfit to take the examination. No applications received after the commencement of the examination can be considered. Students holding vouchers must apply for fresh forms of entry and return them to Local Secretaries on or before August 4 in the year in which they wish to be examined, together with the local expenses fee of Rs. 2.50 (*vide* section 2 of clause 2).

N.B.—The Mathematical Prize will be awarded on the results of the Cambridge Senior Local Examination of December, 1904, to the candidate under 19 years of age who passes the best examination in Mathematics.

NOTES.

Senior and Junior candidates are now allowed to take free composition in French, German, and Spanish, as an alternative to the translation of a continuous passage from English into the language.

Senior candidates taking Algebra will in the future be provided in the examination-room with four-figure tables of logarithms.

The schedules for Junior Mechanics and Senior Applied Mathematics have been modified.

Mensuration and Surveying will henceforth be included as a subject for Juniors.

The arrangement of the Time Tables for Juniors and Seniors has been modified.

A list of the special subjects of examination in December, 1905, can be obtained from the General Secretary on and after September 1, 1904.

EXAMINATION OF JUNIOR STUDENTS.

No one born before December 15, 1888, can be admitted as a Junior Student under the ordinary conditions. Those born before December 15, 1888, may be admitted to the examination, but they can obtain a Pass Certificate only, and are not eligible for marks of distinction.

PART I.—COMPULSORY.

Every student will be required to satisfy the Examiners in (1) Writing from Dictation, and (2) Arithmetic.*

PART II.

The examination will comprise the subjects mentioned in the following sixteen sections. Students will be required to satisfy the Examiners either (a) in three of the sections 1-13 (one at least of the three being 1-9), or (b) in two of the sections 1-13, together with two subjects † out of any other two of these sections (one at least of the two complete sections, or else both the sections from which the two additional subjects are taken, being 1-9). No student may enter for subjects in more than eight sections. One at least of the five subjects of section 1 must be taken by all students, unless their parents or guardians object to their examination in that section.

N.B.—No student can take two papers set at the same time in the Time Table.

A certain number of marks will be assigned to Handwriting. Composition will be taken into account.

Section 1.—RELIGIOUS KNOWLEDGE :

Questions will be set on (a) I. *Kings* ; (b) the Gospel of *St. Matthew*, credit being given for a satisfactory knowledge of the original Greek [or, for Jewish students only, *Joshua* i-xii, xxii-xxiv ; *Judges* i-xii, credit being given for a satisfactory knowledge of the original Hebrew] ; (c) the *Acts of the Apostles*, xiii-xxviii ; (d) the Church Catechism ; (e) *Morning and Evening Prayer* in the Book of Common Prayer. In New Testament subjects special papers in which the Douay Version is used will be prepared for candidates who have been accustomed to the use of that version ‡.

To pass in this section students must satisfy the Examiners in (b) and in one of the subjects (a), (c), (d), (e), to each of which the same credit is given. No student will be examined in more than one of the subjects (a), (c), (d), (e).

Section 2.—ENGLISH LANGUAGE AND LITERATURE :

(a) *English Grammar*, including parsing and the analysis of sentences. Candidates will be required to write a short *English Essay*.

(b) *Shakespeare, Richard II.*

(c) *Scott, Marmion* (including the Introduction to Canto I, but omitting the Introductions to the other Cantos).

(d) *Scott, Kenilworth.*

To pass in this section students must satisfy the Examiners in (a) and either in (b) or in (c) or in (d). No student will be examined in more than one of the three (b), (c), (d).

Section 3.—HISTORY AND GEOGRAPHY :

(a) Outlines of the *History of England* from A.D. 1327 to A.D. 1603.

(b) Outlines of the *History of the British Empire* from A.D. 1492 to A.D. 1784.§

(c) Outlines of *Roman History* from B.C. 27 to A.D. 117.

(d) The Geography of *Great Britain and Ireland*, and *Europe*. An outline map will be given to be filled up by inserting and naming the chief ranges of mountains, the chief towns, the chief lakes and rivers, and the political divisions, and by naming the chief features of the coast line, of some part of these portions of the world. Questions will be set requiring knowledge of the outlines of Physical Geography. Importance will be attached to a knowledge of the relation between the physical features of a country and its political and commercial geography. Medal, see p. 91).

To pass in this section students must satisfy the Examiners in either (a), (b), or (c), and also in (d). No student will be examined in more than one of the three subjects (a), (b), (c).

Section 4.—LATIN :

The papers will include (1) questions on grammar and parsing ; (2) passages for translation from selected books ; (3) one or more easy unprepared passages for translation into English, a vocabulary of the less familiar words being given ; (4) one or more unprepared passages of ordinary difficulty for translation into English ; (5) easy sentences for translation into Latin ; (6) one or more continuous passages for translation into Latin.

The selected books for 1904 are *Cæsar, de Bello Gallico IV.*, V., 1-23, and *Virgil, Æneid I.* Questions may be set on historical and geographical allusions in these books and on the metre of the verse subject. No student may take both authors.

Candidates cannot pass in Latin unless they satisfy the Examiners in accordance, and either in (3) or in (4). They cannot obtain the mark of distinction unless they satisfy the Examiners in (4) and in (6).

Section 5.—GREEK :

The papers will include (1) questions on grammar and parsing ; (2) passages for translation from selected books ; (3) one or more easy unprepared passages for translation into English, a vocabulary of the less familiar words being given ; (4) one or more unprepared passages of ordinary difficulty for translation into English ; (5) easy sentences for translation into Greek.

The selected books for 1904 are *Xenophon, Anabasis III.*, and *Sophocles, Scenes from the Antigone* (Clarendon Press). Questions may be set on historical and geographical allusions in these books and on the metre of the verse subject. No student can take both authors.

Candidates cannot pass in Greek unless they satisfy the Examiners in accordance, and either in (3) or in (4). They cannot obtain the mark of distinction unless they satisfy the Examiners in (4).

* The use of algebraical symbols and processes is permitted. Questions may be set in which contracted methods of multiplication or division are to be used. A knowledge of recurring decimals and of the process of extracting cube root will not be required. Candidates will be expected to know the following tables of weights and measures, namely, avoirdupois, linear measure, square measure, capacity (pints, quarts, gallons) ; and in the metric system, the metre, the gramme, and the litre, with their multiples and submultiples. Questions may be set involving the franc and the centime, the dollar and the cent.

In sections 6, 7, and 8 the paper will include (1) questions on grammar and parsing; (2a) passages for translation into English from selected books, and (2b), as an alternative, unprepared passages for translation into English; (3) one or more easy unprepared passages for translation into English, a vocabulary of the less familiar words being given; (4) one or more unprepared passages of ordinary difficulty for translation into English; (5) easy English sentences for translation into the language; (6a) one or more continuous passages for translation into the language, and (6b), as an alternative, subjects on one of which candidates are to write a short composition in the language.

The unprepared passages set under (2b) will be for those candidates only who do not take a selected book. For those who take selected books questions may be set on historical and geographical allusions and on the metre of verse subjects. The set books for 1904 are as follows: in French, *Ereckmann Chatrian*, *Madame Therese*, Chapters 1-11, and *Dumas, La Fortune de D'Artagnan*, Chapters 1-6 (being chapters 16-21 of *Le Vicomte de Bragelonne*); in German, *Anderson, Eight Stories*, omitting *Ib* and *Christinchen* (Cambridge University Press), and *Schiller, Die Jungfrau von Orleans*; in Spanish, *El Si de las Niñas*. In French and in German no candidate will be examined in more than one of the two selected books.

No candidate may take both (6a) and (6b).

Candidates cannot pass unless they satisfy the Examiners in accordance, and either in (3) or in (4). They cannot gain the mark of distinction unless they satisfy the Examiners in (4) and in (6).

Section 9.—MATHEMATICS:

(a) GEOMETRY.—(See page 91).

(b) ALGEBRA.—Candidates will be required to satisfy the Examiners in definitions and explanations of algebraical signs and terms; addition, subtraction, multiplication, and division of algebraical quantities; theory of indices; highest common factor and lowest common multiple; extraction of the square root; the solution of easy equations of the first degree (including simultaneous equations) and questions producing such equations, and the solution of easy quadratic equations involving one unknown quantity. Questions may be set on graphs; and when such questions are set, squared paper will be provided. Questions will also be set on quadratic equations, the solution of two simultaneous equations, one being linear, the elementary rules of ratio and proportion, arithmetical and geometrical progressions, permutations, combinations, the binomial theorem with positive integral exponents, the theory of indices including the nature of logarithms, and the use of logarithms to the base 10.

(c) PLANE TRIGONOMETRY, including the solution of triangles and the use of logarithms. Questions will not be set involving angles greater than 360 degrees. Candidates will be provided in the examination-room with four-figure tables of logarithms, natural sines, natural tangents, logarithmic sines, and logarithmic tangents.†

(d) ELEMENTARY MECHANICS.—Questions will be set on the composition and resolution of forces acting in one plane at a point, including graphical representation of the same; parallel forces; moments of forces about a point; the properties of the centre of gravity; simple applications to the lever, the common balance, the inclined plane, and the pulley; the composition and resolution of velocities and accelerations in one plane; rectilinear motion with uniform acceleration, including gravity; motion, momentum, force, mass.

Candidates must bring with them a graduated ruler and a protractor.

To pass in this section students must satisfy the Examiners in Geometry and in Algebra.

Section 10.—ELEMENTARY EXPERIMENTAL SCIENCE.‡—Students will be expected to show that they have acquired a practical acquaintance with the elements of physical and chemical measurement, and with the properties of common substances as ascertained by simple experiments.§ Three papers will be set, one of which will be a practical examination.

Section 11.—CHEMISTRY:

(a) THEORETICAL CHEMISTRY.§

(b) PRACTICAL CHEMISTRY.§—Alternative papers are set in this subject, one on Thursday, the other on Saturday; candidates must state in their forms of entry which paper they will take.

To pass in this section students must satisfy the Examiners in both the subjects (a) and (b).

In this section the questions will be principally such as will test the candidates' knowledge of the subject as gained from a course of experimental instruction.

To pass in this section students must satisfy the Examiners in two of the three subjects (a), (b), (c).

EXAMINATION OF SENIOR STUDENTS.

No one born before December 15, 1885, can be admitted as a Senior Student under the ordinary conditions. Those born before December 15, 1885, may be admitted to the Examination, but they can obtain a Pass Certificate only, and are not eligible for marks of distinction.

PART I.—COMPULSORY:

Every student will be required to satisfy the Examiners in Arithmetic.*

PART II.

The examination will comprise the subjects mentioned in the following sixteen sections. Every student will be required to satisfy the Examiners in at least three of the sections 1-16† (one at least of the three being 1-9, and not more than one of the three being 14-16). No student may enter for more than seven sections, together with one subject from an eighth section, subject to the condition that this additional subject will not suffice for a pass in the section. One at least of the four subjects of section 1 must be taken by all students, unless their parents or guardians object to their examination in that section.

(b) MODEL DRAWING, from a group of objects in which there may be included one or more of the following, namely, the cube, cone, cylinder, square pyramid, hexagonal prism, and skeleton cube: the group to be drawn in outline and one of the objects to be shaded.

(c) PERSPECTIVE DRAWING.

(d) DESIGN.—Candidates will be supplied with a photograph or print of some characteristic portion of a plant, and will be required to fill a given space with a coloured design based thereon.

(e) MEMORY DRAWING.—Candidates will be required to draw a simple object from memory, the drawing to be executed in pen and ink.

To pass in this section candidates will be required to satisfy the Examiners in two subjects, of which one must be (a) or (b). They may not take more than one of the three subjects (c), (d), (e).

Section 16.—MUSIC. Questions will be set on Notation; on Scales, Clefs, Keys, Intervals, Time; on the Marks and Terms generally employed in Music; on Cadences; on Triads and Chords of the Dominant Seventh and their Inversions; Single Suspensions; Rhythmical Phrasing. Exercises will be set (on the above Chords) in not more than four parts, in which the highest or the lowest part or both will be given.

CLASS LISTS AND CERTIFICATES.

The names of the boys who pass with credit will be arranged in three honour classes, the first class of juniors being further subdivided into two divisions. In each of these classes and divisions, and also in the list of those who pass to the satisfaction of the examiners, yet not so as to deserve honours, the candidates will be arranged in alphabetical order under the several centres. After the name of every boy will be added the school (if any) from which he comes to attend the examination, and the name of his schoolmaster. *The names of those who pass the Examination for Juniors above the age of 16, and of those who pass the Examination for Seniors above the age of 19 will be placed in lists by themselves, in alphabetical order, not in any class of honours.* Similar classes and lists will be drawn up for girls.

Separate lists will also be given of those junior candidates under the age of 16, and of those senior candidates under the age of 19, who may specially distinguish themselves in particular parts of the examination, and in these lists the candidates will be arranged in order of merit.

The classes of honours are determined solely by the total number of marks obtained by the student. No marks are counted for any subject unless the student passes in that subject. Regard is paid to handwriting and spelling.

The students who pass with credit or satisfy the Examiners will receive certificates to that effect, which will be sent to them through the Local Secretaries. Every certificate will specify the subjects in which the student has passed with credit or satisfied the Examiners, and the class obtained, if any.

DETAILED REPORTS.

After the class lists have been issued in each year, the Syndicate will be prepared to inform the Principals of schools, on receipt of a payment of one shilling for each student, of the manner in which their pupils have acquitted themselves in the several subjects in which they have been examined, describing each as *good, moderately good, &c.*; and also to place their pupils in order of merit among themselves in each subject and on the whole examination. If in any year applications are made by a school on behalf of more than fifty students, the fee payable for each student at that school after the first fifty will be 6d.

EXAMINATION IN SPOKEN FRENCH AND SPOKEN GERMAN (SENIORS).

The Syndicate will arrange for the examination of senior candidates in Spoken French and Spoken German at schools at which the authorities are prepared to pay a fee of one guinea for each language (irrespective of the number of candidates), together with the travelling expenses and the hotel expenses (if any) of the Examiner or Examiners.

Applications must reach the General Secretary not later than October 3, and the examination will be held at some time, between October 3 and the commencement of the local examinations, to be fixed by the Syndicate.

Candidates entering for the spoken examination in either language must also enter for the same language in the Senior Local Examination, and if they pass therein and also in the spoken examination, the fact of their having satisfied the Examiners in the spoken examination will be endorsed on their certificate.

The spoken examination will not be taken into account in determining the position of candidates in the general class list, nor will it be necessary for the mark of distinction in the language. It will, however, be counted towards the mark of distinction in cases where the mark of distinction would not be obtained without it.

Candidates will be required (1) to read aloud a passage of French or German; (2) to write a passage of French or German from dictation; (3) to hold a short conversation in French or German with the Examiner. In 1904 the topics of conversation will be taken partly from *Madame Thérèse*, chapters 1 and 2, or from *Die Jungfrau von Orléans*, Act I.

EXEMPTIONS FROM VARIOUS EXAMINATIONS, &c.

[The Syndicate do not hold themselves responsible for any error caused by changes in requirements with which they have not been made acquainted. Students are referred to the published regulations of the respective institutions.]

A. THE UNIVERSITY OF CAMBRIDGE: PREVIOUS EXAMINATION.—The following are the conditions under which a candidate in the Senior Local Examination is entitled to exemption from parts or the whole of the previous examination (see ** on the following page) :—

(1) From Part I. if the candidate has at one and the same examination shown a sufficient degree of merit in the Gospel (including the Greek text), in Latin, and in Greek.*

(2) From Part II. if the candidate has at one and the same examination shown a sufficient degree of merit in Arithmetic, in Geometry, in Algebra, in Religious Knowledge or Logic, and in English Composition.†

(3) From the additional subjects if the candidate has shown a sufficient degree of merit either in Applied Mathematics or in French or in German.

B. THE SCOTTISH UNIVERSITIES.—The holder of a Senior Certificate is under certain conditions entitled to exemption from portions of the Preliminary Examinations in Arts and Science and in Medicine of the Scottish Universities.

C. THE UNIVERSITY OF BIRMINGHAM.—The holder of a Senior Certificate or of a Junior Certificate (with First or Second Class Honours or with distinction in two subjects which may be either Languages or Mathematics), is under certain conditions entitled to exemption from the Matriculation Examination of the University of Birmingham.

D. THE BOARD OF EDUCATION.—The Code for Public Elementary Schools (1903) sanctions the engagement of holders of the Junior Certificate as pupil teachers (articles 35, 40). Holders of the Senior Certificate who are over 18 years of age may be recognized as assistant teachers, provided that the certificate includes English (article 51 b); if they have obtained a Senior Certificate in Honours, including subjects approved by the Board, they may be proposed by a Training College for admission as King's Scholars (article 115 d).

E. THE GENERAL MEDICAL COUNCIL.‡—The holder of a Senior Certificate is qualified for registration as a Medical or Dental Student provided either (1) that the student has at one or at two examinations passed in (a) English Grammar and Composition, (b) Latin, (c) Mathematics, and either (d) Greek or (e) French or (f) German or (g) Spanish; or (2) that the student has at more than two examinations passed in the above-mentioned subjects with distinction either in English Language and Literature or in one of the subjects (b) to (g).

The holder of a Junior Certificate is qualified for registration as a Medical or Dental Student provided that the student (1) has at one and the same examination passed in (a) English Language and Literature, (b) Latin, (c) Mathematics, including the subject-matter of Euclid, Books I.—III. and Algebra to quadratic equations involving one unknown quantity, and either (d) Greek or (e) French or (f) German or (g) Spanish; and (2) has either (i.) reached the standard for distinction in one of the subjects (a) to (g), or (ii.) reached an Honours standard on the whole examination or in two of the subjects (a) to (g).

F. THE INCORPORATED LAW SOCIETY.—Persons who have obtained a Senior or a Junior Certificate are excused the Preliminary Examination before entering into Articles of Clerkship with Solicitors.

G. THE INSTITUTION OF CIVIL ENGINEERS.—A Senior Certificate exempts the holder from the Studentship Examination, provided that it includes section 2; section 3 (a) or (b), and (d): one of the sections 4 to 8 inclusive; section 9 (including Trigonometry); and either section 10 or section 11.

H. THE ROYAL INSTITUTE OF BRITISH ARCHITECTS.—A Senior Certificate or a Junior Honours Certificate exempts the holder from such of the following subjects of the Preliminary Examination as are included in the Certificate:—English Composition, Arithmetic, Geometry, Algebra, Geography, English History, Latin, French, German, Applied Mathematics.

I. THE INSTITUTE OF CHARTERED ACCOUNTANTS.—Persons who have obtained a Senior Certificate under certain conditions are exempted from the Preliminary Examination. For further information application should be made to the Secretary of the Institute. Senior candidates who seek exemption from the Preliminary Examination of the Institute (for which Dictation is a compulsory subject) may be examined in Dictation if they indicate in their forms of entry that they desire to be so examined.

J. THE SURVEYORS' INSTITUTION.—A Senior Certificate in Honours exempts the holder from the Preliminary Examination of the Institution.

K. THE PHARMACEUTICAL SOCIETY OF GREAT BRITAIN.—The Senior or the Junior Certificate qualifies the holder for registration as a Pharmaceutical Student, provided that it includes English Grammar, Latin, French or German or Spanish, Geometry, and Algebra, passed at the same or at not more than two examinations.

L. THE ROYAL COLLEGE OF VETERINARY SURGEONS.—A Senior Certificate qualifies the holder for admission to the Professional Examination if it includes English Grammar and Composition, Latin, Mathematics, and one of the following: Greek, French, German, Spanish, Logic; and a Junior Certificate if it includes English Grammar, Latin, the subject-matter of Euclid, Books I., II., III., Algebra, and one of the following: Greek, French, German, Spanish. Junior Certificates will not be accepted unless all the necessary subjects have been taken at the same time. This rule does not apply to Senior Certificates.

M. THE INSTITUTE OF CHEMISTRY.—The Senior Examination is accepted as an approved Preliminary Examination provided that the candidate has obtained a certificate including English, Latin, Geometry, Algebra, and one of the following: Greek, French, German, Logic.

N. THE LONDON COUNTY COUNCIL.—(a) Junior county scholars vacating their Scholarships in December are allowed six months' extension of their Scholarships if they pass the Junior Local Examination during the tenure of their Scholarships. (b) Exemption from the preliminary parts of the examination for Intermediate County, Swanley Horticultural, and Domestic Economy Training Scholarships offered by the County Council may be secured in some cases by the Senior and in some cases by the Junior Certificate; particulars may be obtained from the Secretary of the Technical Education Board of the London County Council, 116, St. Martin's Lane, W.C.

* Exemption from Part I. is granted to a candidate who, being a native of Asia and not of European parentage, has at one and the same examination shown a sufficient degree of merit in Latin, in English Composition, in an English Author, and either in one of the Gospels in the authorized English Version or in English History; provided that it has been stated in the form of entry that the candidate claims exemption under this clause, and provided further that evidence satisfactory to the Syndicate is offered showing that the required conditions as to birth and parentage are fulfilled.

† A student who has attained the required standard in Arithmetic, in Geometry, in Algebra, and in Religious Knowledge or Logic, but not in English Composition, is entitled to exemption from Part II. of the previous examination, with the exception of the Essay paper.

‡ Candidates, whether above the age of sixteen or not, who desire to qualify for registration as Medical or Dental Students should make a statement to that effect in their forms of entry. They will then be informed in due course as to whether they have satisfied the prescribed conditions.

** Students desirous of obtaining exemption from Part I., Part II., or the additional subjects of the previous examination may, whether they already hold the Certificate of the Syndicate or not, enter for those subjects alone that are required for the purpose. Students who already hold the Certificate of the Syndicate and desire to add some one or more subjects in order to obtain exemption from a Preliminary Examination, can enter for such subject or subjects alone.* In all such cases the ordinary fee for entrance must be paid.

PRIZES AND MEDALS.

The Syndicate will give prizes to the four candidates who pass the best examination among the senior and junior boys and the senior and junior girls, £12 to each of the two seniors, and £8 to each of the two juniors.

The Council of the Royal Geographical Society offer four silver medals, one for the best senior in Geography (section 3), one for the best senior in Physical Geography (section 12), one for the best junior in Geography (section 3), and one for the best junior in Physical Geography (section 13), if of sufficient merit.

Sir Isaac Pitman and Sons offer two medals, one silver and one bronze, to be awarded to the junior candidates who stand first and second in Shorthand. These medals are open for competition irrespective of the particular systems of Shorthand adopted by the candidates.

The above prizes and medals are not open to juniors above the age of 16 or to seniors above the age of 19.

JUNIOR: PART I.

PRACTICAL GEOMETRY.—The following constructions and easy extensions of them:—Bisection of angles and of straight lines. Constructions of perpendiculars to straight lines. Simple cases of the construction from sufficient data of triangles and of quadrilaterals. Construction of parallels to a given straight line. Construction of angles equal to a given angle. Division of straight lines into a given number of equal parts. Construction of a triangle equal in area to a given polygon. Construction of tangents to a circle. Construction of common tangents to two circles. Construction of circumscribed, inscribed, and escribed circles of a triangle.

Candidates will be expected to be acquainted with the forms of the simpler solid bodies, namely, the cube, the rectangular block, the tetrahedron, the sphere, the cylinder, the wedge, the pyramid, and the cone.

THEORETICAL GEOMETRY.—The substance of the theorems contained in Euclid, Book I., Propositions 4–6, 8, 13–16, 18, 19, 26–30, 32–41, 43, 47, 48; and Book III., Propositions 3, 14–16, 18–22, 31. Questions upon these theorems, easy deductions from them, and arithmetical illustrations will be included.

PART II.

PRACTICAL GEOMETRY.—The following constructions and easy extensions of them:—Construction of a segment of a circle containing an angle of given magnitude. Division of straight lines into parts in any given proportion. Constructions of a fourth proportional to three given straight lines, and of a mean proportional to two given straight lines. Division of straight lines in extreme and mean ratio. Division of a straight line internally or externally into segments so that the rectangle under the parts is equal to a given square. Construction of regular polygons in and about circles. Construction of a circle from sufficient data of the following character: (1) radius given, (2) point on the circle given, (3) contact with a given straight line or circle, (4) contact with a given straight line at a given point. Construction of a rectilinear figure to a specified scale or of a specified area, and similar to a given figure. Construction of a square equal in area to a given polygon. [In cases where the validity of a construction is not obvious candidates may be required to indicate the reasoning by which it is justified.]

Illustration and explanation by means of rectangular figures of the following identities:—

$$\begin{aligned} k(a + b + c + \dots) &= ka + kb + kc + \dots, \\ (a + b)^2 &= a^2 + 2ab + b^2, \\ (a - b)^2 &= a^2 - 2ab + b^2, \\ a^2 - b^2 &= (a + b)(a - b). \end{aligned}$$

THEORETICAL GEOMETRY.—The substance of the theorems contained in Euclid, Book III., Propositions 32, 35–37; Book VI., Propositions 1–8, 19, 20, 33, together with Propositions A and D. Questions upon these theorems, easy deductions from them, and arithmetical illustrations will be included.

In dealing with proportion it may be assumed that all magnitudes of the same kind can be treated as commensurable.

* In certain cases (see above) it is made a condition that all the required subjects shall be taken at the same time.
