PRELIMINARY NOTICE.

Notice under "The Waste Lands Ordinances of 1897, 1899, 1900, and 1903."

TAKE notice, that unless within three months from the 30th day of March, 1904, the persons, if any, who claim any interest in the land hereinafter mentioned, make claim in person or in writing to the said land or to some interest therein to the Assistant Government Agent, Matara, at the Matara Kachcheri:

Such Assistant Government Agent, in pursuance of the powers vested in him by "The Waste Lands Ordinances. 1897, 1899, 1900, and 1903," will declare by writing under his hand that the said land, to which no claim has been made, is the property of the Crown.



FINAL ORDERS.

Order under Section 2 of "The Wate Lands Ordinances, 1897, 1899, and 1900, declaring Lands to be Crown Property.

In the matter of the lands called Padawigampolamukalana, Padawigampolakanda, Gaskadurugahamulahena, Denapitiya Gaskadurugahamulahena, situate in the village of Padavigampola in the Kinigoda korale of the Kegalla District, in the Province of Sabaragamuwa, and of "The Waste Lands Ordinances, 1897, 1899, and 1900."


THE notice required by section 1 of "The Waste Lands Ordinances, 1897, 1899, and 1900," having been duly published in manner prescribed by that section in respect of the above-named lands (vide notice No. 539), and no claim having been made to the said lands or to any interest therein within the period of three months from the date specified in the said notice, the Assistant Government Agent for the Kegalla District, in the Province of Sabaragamuwa, under and by virtue of the powers vested in me in that behalf by section 2 of the said Ordinances, do hereby on this Fifth day of February, 1904, order and declare that the said lands, as more fully described herein below, situate in the village of Padawigampola in the Kinigoda korale of the Kegalla District, in the Province of Sabaragamuwa, and shown as lots 3,711 on preliminary plan 4,984 and lots 5,535, 5,536, 5,537½ on preliminary plan 8,137 and in the annexed certified tracing therefrom, and containing in extent 118 acres 2 roods and 3 perches, are the property of the Crown.

Order under Section 4, Sub-Section (1), of "The Waste Lands Ordinances, 1897, 1899, and 1900," admitting Land to be Private Property.

In the matter of the land commonly called or known as Denapitivagaskadurugahamulahena, situate in the village of Padawigampola in the Kinigoda korale of the Kegalla District, in the Province of Sabaragamuwa, and of "The Waste Lands Ordinances, 1897, 1899, and 1900."

W HEREAS in pursuance of section 1 of the said Ordinances it was duly notified on the Twenty-fifth day of October, One thousand and Nine hundred, that if no claim to the land commonly called or known as Denapitiyagaskadurugahamulahena, situate in the village of Padawigampola in the Kinigoda korale of the Kegalla District, in the Province of Sabaragamuwa, containing in extent 6 acres 3 roods and 22 perches, and shown as lot 5,537 in preliminary plan No. 8,137 as described in the annexed certified tracing therefrom, was made to the Assistant Government Agent of the District of Kegalla within the period of three months from the date specified in such notice, such land would be deemed the property of the Crown and dealt with on account of the Crown:


