# DRAFT ORDINANCES.

# MINUTE.

# The following Draft of a proposed Ordinance is published for general information :—

# An Ordinance for Securing the Public against danger arising from the use of Rifle and Artillery Ranges,

Preamble.

Short title.

Interpretation.

WHEREAS it is expedient to make provision for securing the public against danger arising from the use of rifle and artillery ranges: Be it therefore enacted by the Governor of Ceylon, by and with the advice and consent of the Legislative Council thereof, as follows:

1 This Ordinance may be cited as "The rifle and Artillery Ranges Ordinance, 1904."

2 In this Ordinance, unless the context other wise requires, the expression "military land" includes any part of the seashore or any other Crown or Government land for the time being appropriated to any military purpose with the consent of a Secretary of State or of the Governor, and also any private land so appropriated with the consent of the owner. The expression "military purposes" means all or any of the following purposes, namely, an artillery range, a rifle range, a school of gunnery, experiments connected with gunnery, or any purpose incidental thereto.

The word "seashore" means the space between the sea and the furthest point periodically covered by the sea.

3 (1) The Governor, with the advice of the Executive Council, may from time to time make, and when made may revoke and vary by-laws for regulating the use of any military land for the purpose to which it is appropriated, and for securing the public against danger arising from such use; and may by such by-laws prohibit all intrusion on such land and all obstruction of the said use thereof.

(2) The by-laws when so made, revoked, or varied shall be published in the *Government Gazette*, and shall thereupon become as legal, valid, binding, and effectual as if the same had been inserted in this Ordinance, and all courts, judges, and magistrates shall take judicial notice thereof.

(3) All such by-laws shall be laid before the Legislative Council if in session within one month after such publication, and if not in session, within one month of the commencement of the session next ensuing, and in either case they shall be laid on the table during four sittings at the least of the Council, and any by-law which has been disapproved by resolution of the Council shall cease to have any force or effect.

4 Where any land, the use of which can be regulated by by-laws under this Ordinance, abuts on the sea or on the seashore, this Ordinance shall extend to such sea or seashore as if it were part of such land, and by-laws in relation thereto may be made accordingly. Provided that any such by-laws shall not injuriously affect any right of navigation, anchoring, beaching boats, 'drawing nets, fishing, bathing, walking, or recreation, unless the Governor in Executive Council is satisfied that a restriction of such right is required for the safety of the public or for the exigencies of the military purpose to which the land abutting on the sea or seashore is appropriated, in which case the Governor in Executive Council may make by-laws restricting such rights to such extent as under all the circumstances of the case seems reasonable.

5 Any person committing a breach of any by-law made under this Ordinance shall be guilty of an offence, and shall be liable to be punished on conviction thereof by a fine not exceeding rupees, and in default of payment to simple or rigorous imprisonment not exceeding

#### Statement of Objects and Reasons.

THE general object of the Draft Ordinance is to enable the Governor in Executive Council to pass such by-laws as may be necessary to protect the public from danger arising from the use of military rifle or artillery ranges.

2. The Draft Ordinance (which is based upon Act 48 and 49 Vict. c. 36) applies to any military land appropriated for the purposes of a rifle range, an artillery range, a school of gunnery, or any incidental purpose.

3. In the case of military land abutting on the sea or on the seashore, the Ordinance extends to such sea or seashore, but provision is made that by-laws passed under the Ordinance shall not injuriously affect any right of navigation, anchoring, beaching boats, drawing nets, fishing, bathing, walking, or recreation, unless the Governor in Executive Council is satisfied that a restriction of the right is required for the safety of the public, in which case by-laws may be made restricting the rights to such extent as under all the circumstances of the case seems reasonable.
