NOTICES UNDER THE WASTE LANDS ORDINANCES.

[Notice under "The Waste Lands Ordinances, 1897, 1899, and 1900."]

TAKE notice, that unless within three months from the 13th day of December, 1901, the persons, if any, who claim any interest in the lands hereinafter mentioned or in any one or more of such lands, appear before the Special Officer appointed under section 28 of "The Waste Lands Ordinances, 1897, 1899, and 1900," at his office at Galle and make claim to the said lands or any of them or to some interest therein:

Such Special Officer, in pursuance of the powers vested in him by the said Ordinances, will declare by writing under his hand that the said lands or such of them, as to which no claim has been made, are the property of the Crown.

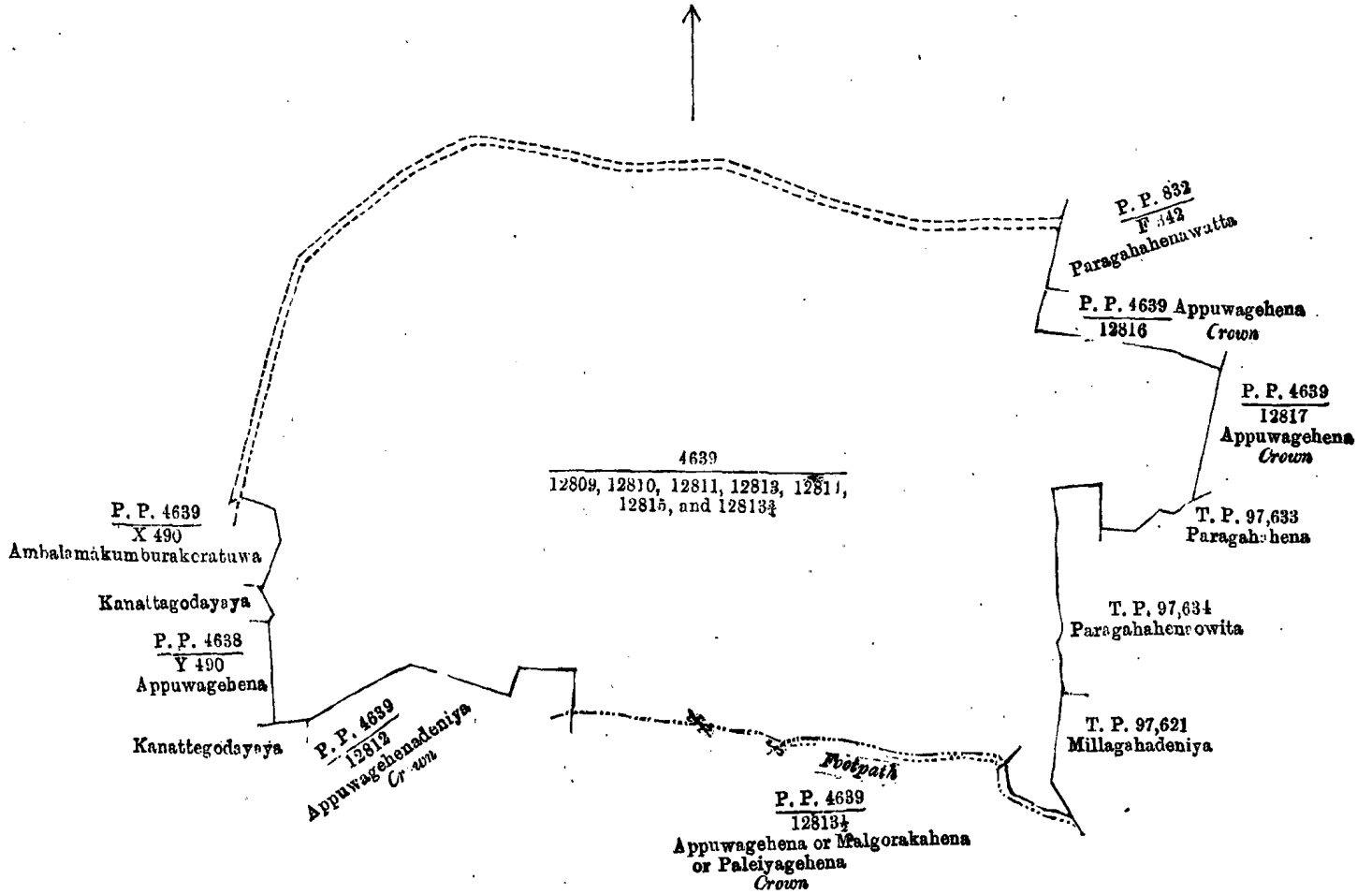

and bounded as follows: on the north by the road from Kamburugamuwa to Kanattegoda; on the east by Paragahahena-watta (F 342) claimed by Don Siman Atapattu Appuhami, Appuwagehena (12,817 & 12,816) belonging to Crown, Paragahahena sold by Crown to N. A. Siman Appu (T. P. 97,634), Millagahadeniya sold by Crown to D. C. A. Siriwardana (T. P. 97,621); on the south by the village limit of Kanattegoda, the footpath from Kamburugamuwa to Kanattegoda, Appuwagehena alias Malgorakehena alias Palliyagehena (12,813½) belonging to Crown, Appuwagedeniya (12,812) belonging to Crown, Kanattegodayaya belonging to Warnasuriya Patabendige Don Dionis and others; on the west by Appuwagehena claimed by Gallere Kaluwa (4,639 / Y 490), Kanattegodayaya belonging to Warnasuriya Patabendige Don Dionis and others, Ambalame-kumburakoratuwa (4,639 / X 490) belonging to Galhenage Kaluwa, the road from Kamburugamuwa to Kanattegoda.
