NOTICE UNDER THE WASTE LANDS ORDINANCES, 1897, 1899, AND 1900.

TAKE notice, that unless within three months from the 17th day of January, 1902, the persons, if any, who claim any interest in the land hereinafter mentioned, appear before the Special Officer appointed under section 28 of "The Waste Lands Ordinances, 1897, 1899, and 1900," at his office at Galle and make claim to the said land or to some interest therein :

Such Special Officer, in pursuance of the powers vested in him by the said Ordinances, will declare by writing under his hand that the said land, to which no claim has been made, is the property of the Crown.

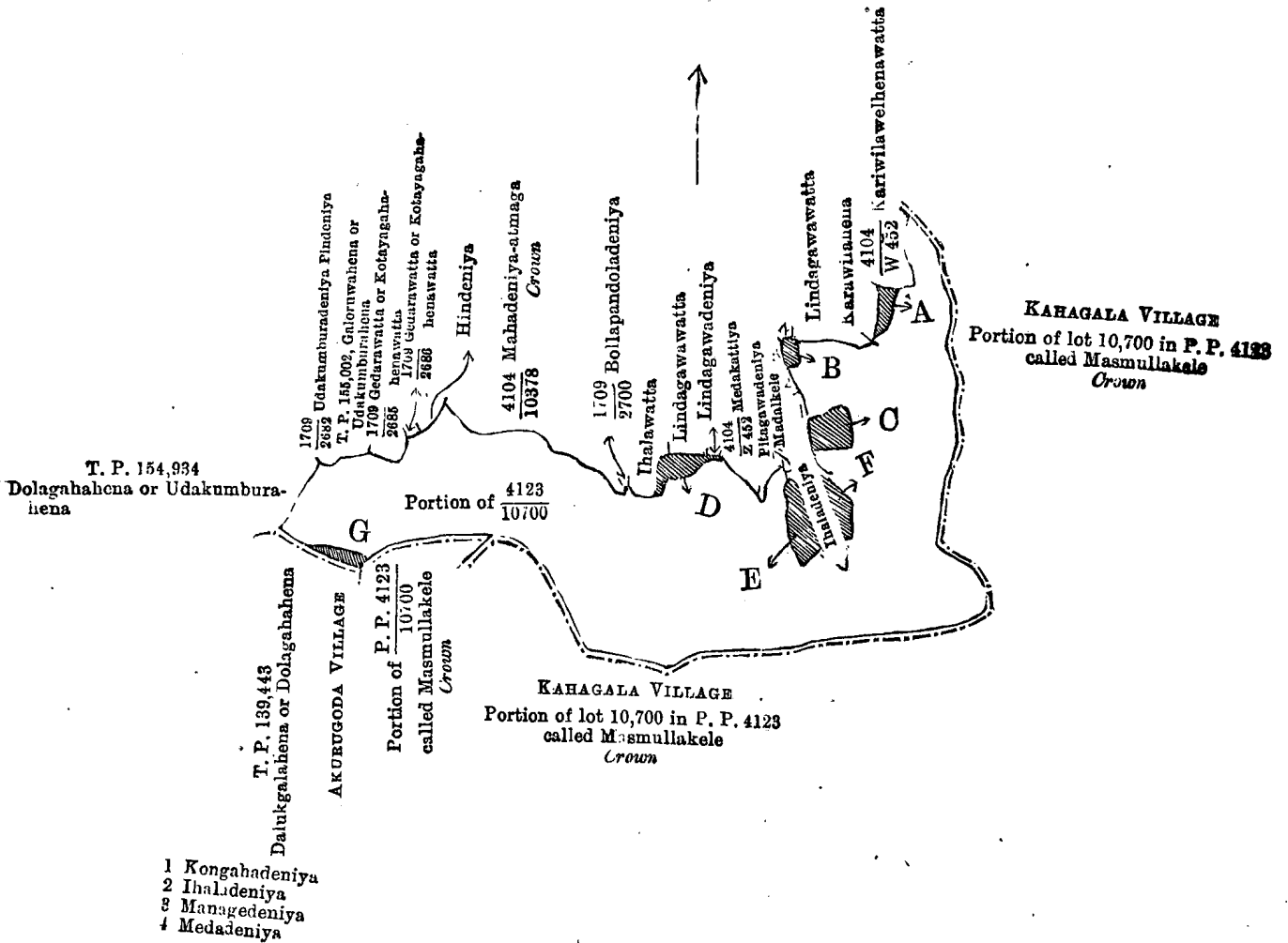
