NOTICE UNDER THE WASTE LANDS ORDINANCES, 1897, 1899, AND 1900.

TAKE notice, that unless within three months from the 17th day of January, 1902, the persons, if any, who claim any interest in the lands hereinafter mentioned or in any one or more of such lands, appear before the Special Officer appointed under section 28 of "The Waste Lands Ordinances, 1897, 1899, and 1900," at his office at Galle and make claim to the said lands or any of them or to some interest therein :

Such Special Officer, in pursuance of the powers vested in him by the said Ordinances, will declare by writing under his hand that the said lands or such of them, as to which no claim has been made, are the property of the Crown.

Description of Lands referred to.

I.

The land commonly called or known as Masmullekele, situate in the village of Akurugoda in the Gangaboda pattuwa of the Matara District, in the Southern Province, containing in extent 11 acres 2 roods and 82 perches, shown as a portion of lot 10,700 marked A in preliminary plan 4,123, and in the annexed certified tracing, and bounded as follows : on the north by the village limit of Kahagala, (portion of 4,123 / 10,700) called Masmullekele belonging to Crown ; on the east by the village limit of Kahagala, (portion of 4,123 / 10,700) called Masmullekele belonging to Crown ; on the south by Puwakketiyeewatta belonging to Manage Punchihami and others, Gounagahawatta belonging to Samaranyaka Patiranaage Charles and others ; on the west by Dalukgalahena alias Dolégaheena sold by Crown to Wijesinha Muhandirange Don Cornelis and others (T. P. 139,443), Masmullekele (4,111 / 10,432) belonging to Crown.

II.

The land commonly called or known as portion of lot 4,123 / 10,700 Masmullekele, situate in the village of Akurugoda in the Gangaboda pattuwa of the Matara District, in the Southern Province, containing in extent 7 acres and 7 perches, shown as a portion of lot 10,700 marked B in preliminary plan 4,123, and in the annexed certified tracing therefrom, and bounded as follows: on the north by Danahalamulledeniya belonging to Manage Sabe and others ; on the east by the village limit of Kahagala (portion of 4,123 / 10,700) called Masmullekele belonging to Crown ; on the south by the village limit of Urapola, (portion of 4,123 / 10,700) called Masmullekele belonging to Crown ; on the west by the village limit of Urapola and Palupansalehena alias Talakolahen-pitahena sold by Crown to Mr. J. D. S. Wijesinha, Mudaliyar (T. P. 129,728).

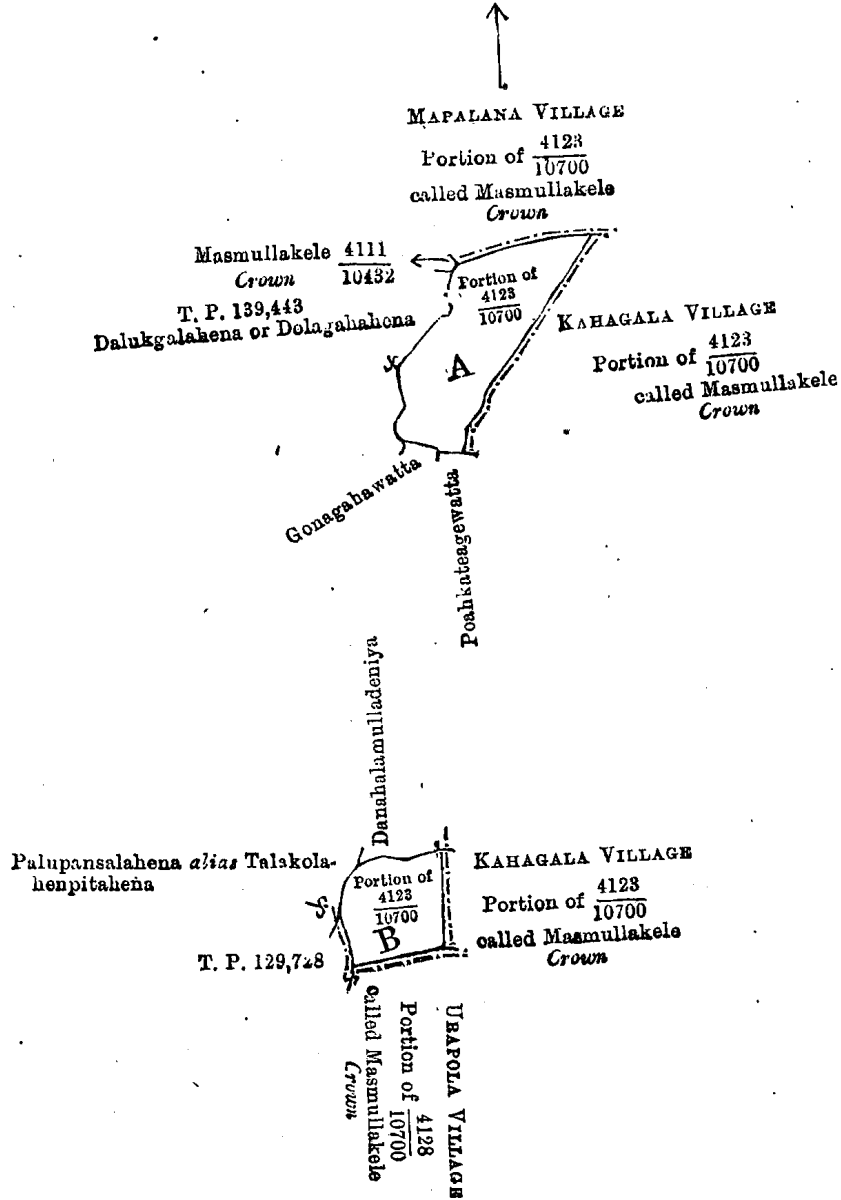
