NOTICE UNDER THE WASTE LANDS ORDINANCES, 1897, 1899, AND 1900.

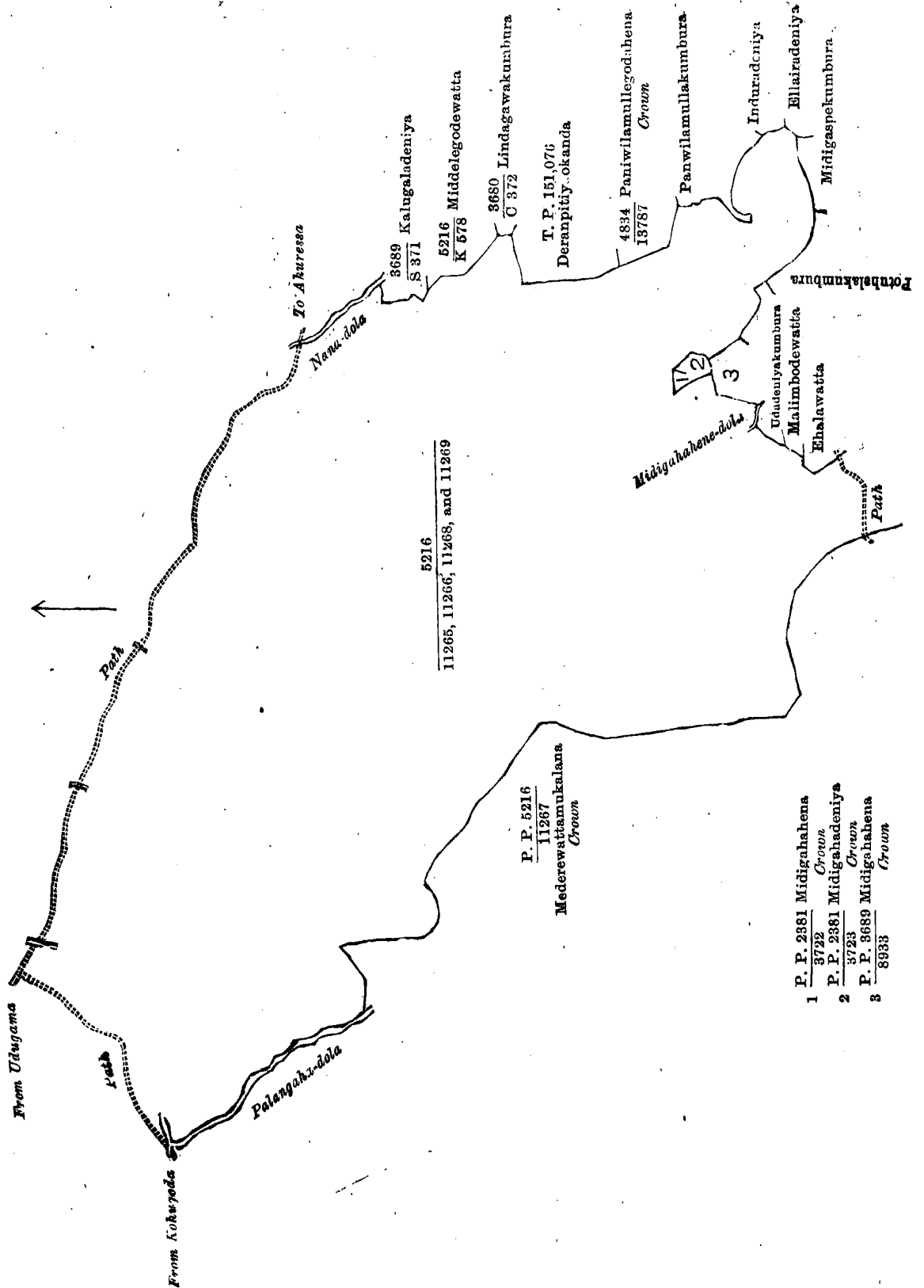
