THE following regulations made by His Excellency the Governor, with the advice of the Executive Council, under section 9 of the Ordinance No. 11 of 1901, to regulate the possession and sale of poisons, are published for general information.

Regulations under "The Poisons Ordinance, 1901."

The list of poisons under Schedule A shall be divided into two parts.

2. The following shall come under Part I.:--

Arsenic and its preparations.

Prussic acid.

Cyanides of potassium and all metallic cyanides.

Strychnine and all poisonous vegetable alkaloids and their salts.

Aconite and its preparations.

Emetic tartar.

Corrosive sublimate.

Cantharides.

Savin and its oil.

Ergot of rye and its preparations.

Datura and its preparations.

All poisonous vegetable alkaloids and their salts.

Atropine and its preparations.

Preparations of cantharides.

Preparations of metallic cyanides.

Preparations of strychnine.

All vermin killers containing any of the above preparations.

3. The poisons under Part I. shall not be sold by retail, unless the purchaser is known to, or is introduced by, some person known to the seller. An entry shall be made of every sale, by the seller, in a register in the form appearing in Schedule C annexed to the Ordinance.

4. The vessel, packet, and wrapper containing the poison shall be distinctly labelled with the name of the article and the word "Poison" in English, Sinhalese, and Tamil, and with the name and address of the seller.

5. The following poisons shall come under Part II.:-

Carbolic acid.

Oxalic acid.

Chloroform.

Belladonna and its preparations.

Essential oil of almonds, unless deprived of its prussic acid.

Opium and all preparations of opium or of poppies.

Chloral hydrate and its preparations.

Corrosive sublimate preparations and all other mercury salts.

Nux vomica and its preparations.

The above articles shall be sold only with the vessel, wrapper, and cover distinctly labelled with the name of the article, the word "Poison" in English, Tamil, and Sinhalese, and with the name and address of the seller.

6. Arsenic when sold by retail shall be mixed with powdered charcoal or indigo to colour it. All poisons enumerated in Part I. and Part II. shall be

sold only to persons of mature age.

7. None of the foregoing regulations shall apply to any article when forming part of the ingredients of any medicine dispensed by an apothecary, or chemist and druggist on a doctor's prescription, but all such prescriptions, if containing any of the poisons enumerated, shall be entered in a book kept for that purpose (Prescription Book), with the name of the person to whom it was sold and the name of the doctor prescribing. The name and address of the seller shall be attached to the receptacle containing the medicine prescribed.

8. Poisons kept for sale shall be securely packed in strong jars, bottles, or other similar suitable vessels, and the name of the poison contained in each such jar, bottle, or vessel shall be affixed thereto in distinct letters and

such jar, bottle, or vessel shall be kept under lock and key.

9. The apothecaries in Government employment shall be exempted from obtaining the license referred to in clause 3 of the Ordinance, but they shall

in all other respects comply with the provisions of the Ordinance.

10. The license to be issued by a Government Agent under the provisions of section 4 of the Ordinance shall specify the name of the person to whom it is granted, the place at which the poisons are to be sold, whether the sale is to be wholesale or by retail, and the conditions, if any, upon which such license is granted.

Tenders are invited for the purchase of the trees numbered as they stand in the forest. Offers will be received for the purchase of-

(a) All the trees in the whole forest;

(b) All the trees of any particular description in the whole forest;

(c) All the trees in one or more of the compartments;

(d) All the trees of any particular description in any one or more of the compartments.

Tenders will not be received for a limited number of trees to be selected out of the forest or any compartment. Offers may be made of lump sums or rates per tree or cubic foot, written both in figures and words. It should be stated in each tender how payment of the purchase money will be made, and within what time the trees purchased will be felled and removed from the forest.

No satinwood tree felled will be considered a "hollow log," unless the hollow extends its whole length and is no where less than 9 inches in diameter.

Logs sold as sound, but proving on felling to be hollow or rotten, must nevertheless be brought out to the Hambantota Depôt by the purchaser, where they will be sold by public auction and 60 per cent. of the proceeds paid over to the purchaser.

In the event of a rate per cubic foot being accepted, 10 per cent will be allowed for bark, &c., off cubical

contents calculated from actual measurements of felled log.

Logs will not be considered hollow or rotten if the unsoundness is slight and extends duly a few feet, nor will cracks be considered unsoundness. The decision on these points to rest with the Assistant Government Agent.

The original tender must be sent to the Assistant Government Agent, Hambantota, and the duplicate of it direct to the Hon. the Auditor-General, both being despatched at the same time.

Should the person tendering decline to enter into the contract and bond, or fail to furnish security, such deposit will be forfeited to the Crown.

All alterations in the tender must be initialled by the person signing it.

Five per cent. of the total sum which under this contract will have to be paid by the contractor must be deposited as security for the due fulfilment of the contract before it is signed.

The Government reserves to itself the right, without question, of rejecting any or all tenders.
