## FINAL ORDERS.

Order under Section 4, Sub-section (1), of "The Waste Lands Ordinances of 1897, 1899, 1900, and 1903," declaring the Land to be Crown Property.

In the matter of the land commonly called or known as Pinhena, Dadakirigahahena, Medakuttiya, &c., situate in the village of Bodimaluwa in the Giruwa Pattu West of the Hambantota District, in the Southern Province, and of "The Waste Lands Ordinances of 1897, 1899, 1900, and 1903."

WHEREAS in pursuance of section 1 of the said Ordinances it was duly notified on the 11th day of March, One thousand Nine hundred and Four, that if no claim to the land commonly called or known as Pinhena, Medakuttiya, &c., situate in the village of Bodimaluwa in the Giruwa Pattu West of the Hambantota District, in the Southern Province, containing in extent 11 acres 1 rood and 29 perches, and shown as lot 3 in preliminary plan No. 142 and in the annexed certified tracing therefrom, was made to the Special Officer appointed under section 28 of the said Ordinances within the period of three months from the date specified in such notice, such land would be deemed the property of the Crown and dealt with on account of the Crown (vide notice No. 1,873):

And whereas Pallattara Ratnapala Terunnanse, Incumbent of Naigala and Bodimaluwa temples, made claim thereto; and whereas the said claimant has withdrawn his claim to the said land, I, John George Fraser, Special Officer appointed under section 28 of the said Ordinances, under and by virtue of the powers vested in me in that behalf by section 4 of the said Ordinances, do hereby on this 9th day of December, 1904, order and declare, under section 4, sub-section (1), of the said Ordinances, that the said land, as more fully described herein below, is the property of the Crown.




