Order under Section 4, Sub-section (1), of "The Waste Lands Ordinances of 1897, 1899, 1900, and 1903," declaring the Land to be Crown Property.

In the matter of the land commonly called or known as Uhampitiya, and more particularly as Paluvattehenyaya, Damunugahakele or Kongahawattehena, Damunugahakele, Ottunsantakekele, and Kongahawatte, situate in the village Uhampitiya in the Kumarapallam pattu of Demala hatpattu in the Puttalam District, in the North-Western Province, and of "The Waste Lands Ordinances, 1897, 1899, 1900, and 1903."


W HEREAS in pursuance of section 1 of the said Ordinances it was duly notified on 13th December, 1901, that if no claim to the land commonly called or known as Uhampitiya, and more particularly as Paluvattehenyaya, Damunugahakele or Kongahawattehena, Damunugahakele, Ottunsantekele, and Kongahawatte, situate in the village Uhampitiya in the Kumarapallam pattu of the Demala hatpattu in Puttalam District of the North-Western Province, containing in extent 68 acres and 31 perches, and shown as lots 1, 2, 3, and 4 in the Waste Land Ordinance plan 28! and


