

FINAL ORDERS.

Order under Section 4, Sub-section (1). of "The Waste Lands Ordinances, 1897, 1899, and 1900," relating to Claims to Forest, Chena, Waste, and Unoccupied Lands.

In the matter of the land commonly called or known as Amunekumbura or Kiradeniya, situate in the village of Kappagoda in the Galboda korale of the Kegalla District, in the Province of Sabaragamuwa, and of "The Waste Lands Ordinances, 1897, 1899, and 1900."

WHEREAS in pursuance of section 1 of the said Ordinances it was duly declared and notified on the Tenth day of March, One thousand Nine hundred and Two, that if no claim to the land commonly called or known as Amunekumbra or Kiradeuiva, situate in the village of Kappagoda in the Kegalla Distrct, in the Province of Sabaragamuwa, containing in extent 5 acres and 19 perches, and shown as lot 4,950 in preliminary plan No. 7,947, was made to the Assistant Government Agent of the District of Kegalla within the period of three months from the date specified in the said notice, such land would be deemed the property of the Crown and dealt with on account of the Crown :

And whereas the claimants referred to in the annexed Schedule A made claim thereto; and the Assistant Government Agent for the Kegalla District, in the Province of Sabaragamuwa, made due inquiry into such claim; and whereas he and the said claimants have come to an agreement in writing concerning the said land, under section 4, sub-section (1), of the said Ordinances:

Ukku Banda; on the south by Amunekumbura or Kiradeniya (P.P. $\frac{1,165}{3,126}$) claimed by D. Balaya; on the west by Amunekumbura claimed by Ran Menika.

3. Amunekumbura or Kiradeniya (P.P. $\frac{1,165}{3,126}$), containing in extent 3 roods and 24 perches:

on the north by Amunekumbura or Kiradeniya (P.P. $\frac{1,165}{3,125}$) claimed by D. M. Biso Banda and another; on the east by Hanagewatta claimed by M. Ukku Banda; on the south by Amunekumbura or Kiradeniya (P.P. $\frac{1,165}{3,127}$) claimed by B. Horatala; on the west by a portion of Kudadurayawatta claimed by Dingirihami and a portion of Amunekumbura claimed by Ran Menika.

4. Amunekumbura or Kiradeniya (P.P. ^{1,165}_{3,127}), containing in extent 3 roods and 36 perches:

Hanagewatta claimed by M. Ukku Banda; on the south by Amunekumbura or Kiradeniya (P.P. $\frac{1,165}{3,128}$) claimed by Vidanelage Dingiri Appu; on the west by a portion of Kiradeniya claimed by Sirimala and a portion of Kudadurayawatta claimed by Dingirihami.

5. Amunekumbura or Kiradeniya (P.P. $\frac{1,165}{3,128}$), containing in extent 3 roods and 34 perches: on

the north by Amunekumbura or Kiradeniya (P.P. 3,127) claimed by B. Horatala; on the east by Hanagewatta claimed by M. Ukku Banda; on the south and west by Nagasmullahena claimed by Kiri Banda and Kiradeniya claimed by Sirimala.

And whereas the said claimants referred to in the annexed Schedule A have duly paid this amount as agreed, the said claimants are hereby declared to be the purchasers of the said lands as described above.



W HEREAS in pursuance of section 1 of the said Ordinances it was duly declared and notified on the 10th day of March, One thousand Nine hundred and Two, that if no claim to the lands commonly called or known as Nakandawalehena, Horaladeniya, or Pusselandehena, situate in the village of Kappagoda in the Kegalla District, in the Province of Sabaragamuwa, containing in extent 19 acres and 24 perchas, and shown as lots W 437, 4,947 in preliminary plan No. 7,947, was made to the Assistant Government Agent of the District of Kegalla within the period of three months from the date specified in the said notice, such lands would be deemed the property of the Crown and dealt with on account of the Crown:

And whereas (1) Gauegerallage Mudiyanse, (2) Gauegerallage Kiri Banda, both of Kappagoda, made claim to Nakaudawalehena (P.P. $\frac{7,947}{W437}$) and to a portion of Horaladeniya or Pusselandehena



In the matter of the land commonly called or known as Horaladeniya or Pusselandehena, situate in the village of Kappagoda in the Galboda korale of the Kegalla District, in the Province of Sabaragamuwa, and of "The Waste Lands Ordinances, 1897, 1899, and 1900."

HEREAS in pursuance of section 1 of the said Ordinances it was duly declared and notified on the tenth day of March, One thousand Nine hundred and Two, that if no claim to the land commonly called or known as Horaladeniya or Pusselandehena, situate in the village of Kappagoda in the Kegalla District, in the Province of Sabaragamuwa, containing in extent 18 acres 2 roods and 8 perches, and shown as lot 4,947 in preliminary plan No. 7,947, was made to the Assistant Government Agent of the District of Kegalla within the period of three months from the date specified in the said notice, such land would be deemed the property of the Crown and dealt with on account of the Crown :

And whereas Vidanahenayalage Somina Henaya of Walaporuwa made claim to a portion thereof, and the Assistant Government Agent for the Kegalla District, in the Province of Sabara-gamuwa, made due inquiry into such claim; and whereas he and the said claimant have come to an agreement in writing concerning the said land, under section 4, sub-section (1), of the said Ordinances :

It is hereby ordered, in pursuance of the agreement afore-mentioned, that the said Vidanahenayalage Somina Henaya do pay to the Assistant Government Agent at Kegalla a sum of Rupees Thirty (Rs. 30) as purchase amount for 1 acre and 7 perches of lot 4,947 on preliminary plan 7,947, subsequently marked off as lot 3,123 on preliminary plan 1,165, as more fully described hereinafter :---

Lot 3,123 in preliminary plan 1,165 called Horaladeniya or Pusselandehena, containing in extent 1 acre and 7 perches, as described in the annexed plan, and bounded on the north and west by Amunekumbura or Kiradeniya (P.P.^{1,165}) claimed by the Crown, on the east by Asweddumawatta

(P P. 7,947) claimed by Ukkuwa Henaya and Asweddumakumbura (P.P. 7,947) claimed by M. Ukku Banda, on the south by Asweddumakumbura claimed by Ninasatampi and Maranalla claimed by M. Ukku Banda.


