NOTICE UNDER THE WASTE LANDS ORDINANCES, 1897, 1899, AND 1900.

TAKE notice, that unless within three months from the 27th day of March, 1902, the persons, if any, who claim any interest in the lands hereinafter mentioned or in any one or more of such lands, appear before the Special Officer appointed under section 28 of "The Waste Lands Ordinances, 1897, 1899, and 1900," at his office at Galle and make claim to the said lands or any of them or to some interest therein :

Such Special Officer, in pursuance of the powers vested in him by the said Ordinances, will declare by writing under his hand that the said lands or such of them, as to which no claim has been made, are the property of the Crown.

Description of Lands referred to.

I.

The land commonly called or known as Kitulpelahena, situate in the village of Meloggamuwa in the Morawak korale of the Matara District, in the Southern Province, containing in extent 16 acres 1 rood and 39 perches, shown as lot 7 in sheets O 15/3-11 and O 15/4-12 and in preliminary plan 19, as described in the annexed certified tracing therefrom, and bounded as follows : on the north by Millagasmulla-addarawatta belonging to Konkaduwege Punchiappu and others, Etawetunadeniya belonging to Crown, the footpath, the village limit of Moragala ; on the east by the water-course, Egodadeniyewatta belonging to Konkaduwege Punchiappu and others, Wattagawadeniya belonging to ditto ; on the south by Meegaswatteatura belonging to Crown, Kalngalagawadeniya belonging to Crown, Paredeniyehena belonging to Crown ; on the west by Polgahawila belonging to Konkaduwege Punchiappu and others.

දකුණු පලාතට අයිති මාතර දිස්ත්‍රික්කේ මොරවක්කෝරලේ මොලොග්ගමුව යන ගම පිහිටා තිබෙන මීට අමුතාපු සහතික සිතියමේ පේන අක්කර 16කුත්, රූඩ් 1කුත් පර්චස් 39ක් බිම්කරම ඇති සාමාන්‍යවසයෙක් කිතුල්පැලුණේන කිසන නොහොත් ඒ නමින් දැනගණ තිබෙන O 15/3-11 සහ O 15/4-12 සිතියමපහුවල සහ 19යේ මුල් සිතියමේ පේන 7න් පෙන්වන බිම්කට්ටියට මාසිම්—උතුරට කෝන් කඩුවේගේ පුන්විආප්පුට සහ තවත් අයවළුන්ට අයිති මිල්ලගස්මුල්ලේඅද්දර වත්තද, රාජසන්තක ඇතැවැදුන දෙනියද, අභිපාරද, මොරගල ගම් ඉමද; හැගණඉරට වතුර බස්නාවද, කෝන්කඩුවේ ගේ පුන්විආප්පුට සහ තවත් අයවළුන්ට අයිති එගොඩදෙනියේ වත්තද, එම අයවළුන්ට අයිති වත්ත ගාවා දෙනියද; දකුණට රාජසන්තක මිහස්වත්තේ අතුරද, රාජසන්තක කළුගලොවා දෙනියද, රාජ සන්තක පරේදෙනියේ ශේනද; බස්නාඉරට කෝන්කඩුවේගේ පුන්විආප්පුට සහ තවත් අයවළුන්ට අයිති පොල්ගහවිලද.

இவ்வறிவித்தலின் தேதியாகிய 1902 ம் ஆண்டு-த்து பங்குனி 27 ந்த தேதியிலிருந்து மூன்று மாதத்திற்குள்ளாக இதன் கீழ் விவரித்திருக்கும் காணிகளை அல்லது அக்காணிகளின் வெவ்வேறையும் குறித்து உரித்துப்பெசுவோர்கள் யாருமிருந்தால், அவர்கள் 28 ம் பிரிவின்படி பாளாண காணிகளின் சட்டங்களின் 1897, 1899, 1900 ம் வருஷங்களில் ஏற்படுத்திய குறிப்பான உத்தியோகஸ்தர் முன்பாக காலி அவரது கத்தோரில் தெரிபட்டு மேற்படி காணிகளை அல்லது அவற்றி் வெதையும் குறித்து யாதும் உரிமை அல்லது உடந்தை காணியாதிருந்தால், மேற்சொல்லிய குறித்த உத்தியோகஸ்தராக தம்மில் சொல்லப்பட்ட கட்டணச்சட்டங்களினால் தனக்குக் கொடுத்திருக்கும் தத்துவங்களைக்கொண்டு தன் கையொப்பமிட்டு எழுத்து மூலமாய் சொல்லப்பட்ட காணிகளை அல்லது அவைகளின் உரித்தைப் பேசப்பட்டவர்கள் வெளிப்படாவிடில் முடிக்குரிய ஆதனமென்று வெளியரங்கப்படுத்துவார்.

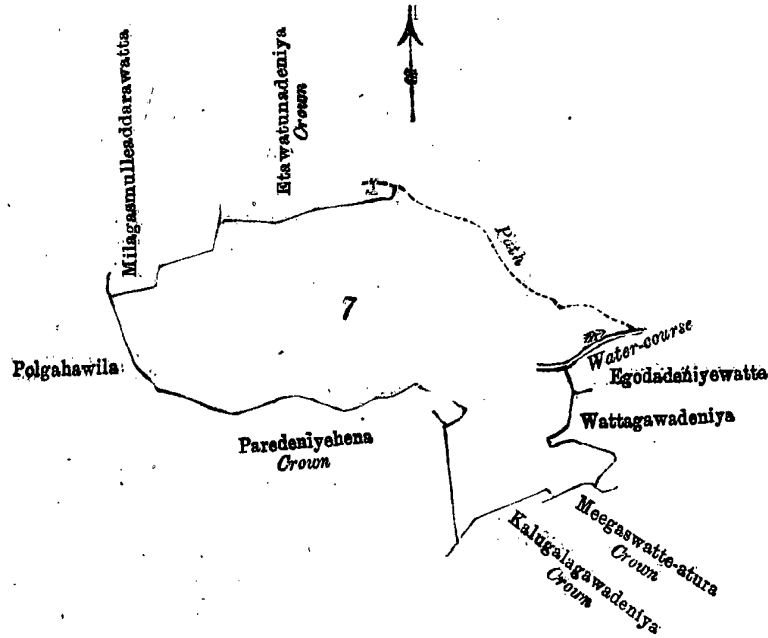

தென் மாகாணத்தின் மாத்துறை முஸ்திரிக்கில் மொறவக்கோறையைச்சேர்ந்த மொளொக்கமுலை யென்னும் கிராமத்திலுள்ள $0 \frac{15}{3-11}$ ம், $0 \frac{15}{4-12}$ ம் அளவுக்கட்தாசியிலும் 19 ம் இலக்க பிரதமபடத்திலும் காணப்படும் பங்கு 7 ம் பிரிவு படி கிதள்பெளகேன என்று பொதுவாய்ச் சொல்லப்படுகிற அல்லது அறியப்படுகிற இத்தோடணத்திற்குக்கும் குறிக்கப்பட்ட உறுதிப்படுத்திய டாப்பில் விவரிக்கப்பட்டதும் 16 ஏக்கர் 1 டாட் 39 பர்சஸு விஸ்தாரமுள்ளது :-

The land commonly called or known as Udakumburagawakoratuwa, situate in the village of Mologgamuwa in the Morawak korale of the Matara District, in the Southern Province, containing in extent 2 acres and 28 perches, shown as lot 3 in sheet $0 \frac{15}{3-11}$ and in preliminary plan 19, as described in the annexed certified tracing, and bounded as follows : on the north by Polgahawila belonging to Konkaduwege Punchiappu and others; on the east by Polgahawila belonging to Konkaduwege Punchiappu and others, Paredeniyehena belonging to Crown; on the south by Tebuattumulla sold by Crown to Hewawitaranage Dinakahami (T. P. 153,937); on the west by Polgahawila belonging to Konkaduwege Punchiappu and others.
