2. The tenders, which must be in sealed envelopes superscribed "Tender for purchase of Ambana Land," should be handed personally to the Government Agent at his office in Colombo at 12 o'clock on Tuesday, January 23, 1906. No tenders will be received after 12.30 P.M. on the appointed day.

3. All tenders shall be subject to the approval of His Excellency the Governor. The Government Agent reserves to himself the right to reject any or all tenders.

4. The person whose tender is selected by the Government Agent will be required at once to sign the usual conditions of sale for purchase of Crown land and deposit one-tenth of the amount of tender, the balance amount of tender should be paid within a month from the date of notification of the acceptance of the tender.

5. The conditions of sale of Crown land can be obtained at any Kachcheri in the Island. Any further information will be supplied by the Government Agent or the Surveyor-General.

6. In the event of two or more tenders being for an equal amount, the Government Agent shall have the option of forthwith offering the land for sale by public auction, the bidding to be restricted to the tenderers in question, or of calling for fresh tenders.

7. The land in question is situated about one-eighth of a mile from the railway station at Mirigama. It also adjoins the road from Mirigama to Negombo.
